**Cook Inlet Earthquake**

The SEOC continues to be activated to Level 3 in response to the M7.0 earthquake affecting the Municipality of Anchorage, Matanuska-Susitna Borough, and Kenai Peninsula Borough. The State has activated the State Individual Assistance Program for earthquake survivors. 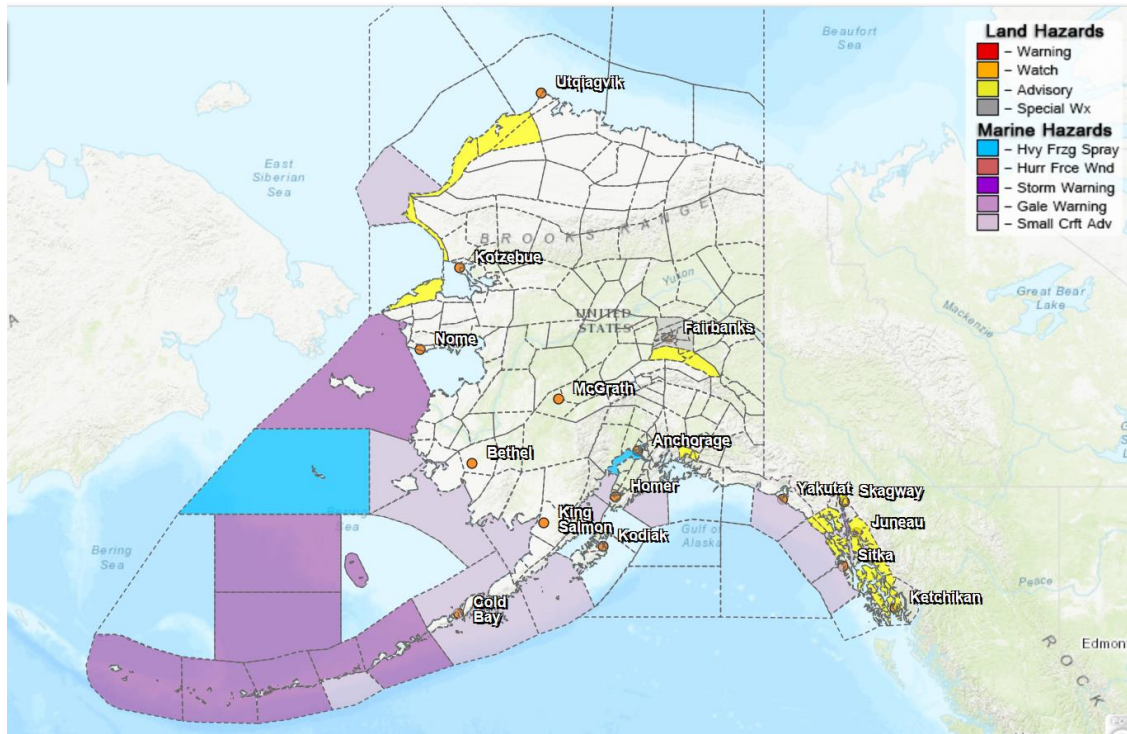
**Thorne Bay Landslide**

SEOC received a signed local declaration of disaster emergency from the City of Throne Bay and Kasaan requesting State assistance in response to the January 2, 2019 landslide that has interrupted power, blocked the primary roadway, compromised emergency services access, and disrupted commerce. SEOC spoke with the City today and they are working on an agreement with the State Mental Health Trust and US Forest Service for a temporary emergency access road across their properties. SEOC is assisting the Cities in investigating Federal Highway Administration applicability and funding for the blocked primary roadway.
