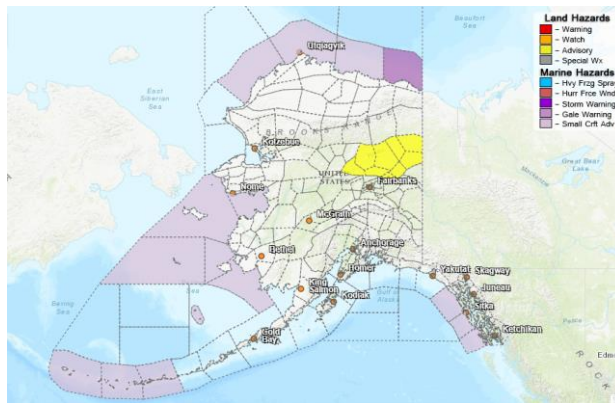

**THREAT LEVEL CHANGES:** LEVEL 2 – HEIGHTENED AWARENESS

Yesterday afternoon (7/23), the SEOC received a call from the Power Plant Operator (PPO) for Arctic Village regarding a partial power outage in the community. It appears power is out to the phone/internet building and 12-14 homes. The clinic, washeteria, and school are unaffected. The PPO contacted GCI who plans to charter a flight out to Arctic Village to deliver a portable generator to power their communications building. The SEOC has contacted the Alaska Energy Authority (AEA) who was unaware of the outage. AEA will contact the PPO and determine how best to help them restore power, then advise the SEOC on their response plan.

**Statewide Fires:** The SEOC remains activated at Level 2 – Heightened Awareness due to the statewide wildfire situation. The SEOC is monitoring fire activity statewide for support requests from Fire Incident Commands and local communities impacted by fire. The SEOC continues to coordinate deployments of mobile communication equipment in support of Alaska Division of Forestry and local communities. The SEOC is also monitoring dense smoke advisories statewide.

**Signiant Weather**



The National Weather Service in Fairbanks has issued a Dense Smoke Advisory for the Yukon Flats, Delta Junction and surrounding areas, which is in effect until 12:00am AKDT Thursday.
