**Significant Issues:**

The SEOC is monitoring a storm related power outage in Diomedes. The SEOC has been in contact with the community, assisting agencies and the local government specialist. Repairs are expected as soon as Sunday afternoon. No injuries or other reports of damage were reported and there are no requests for additional State assistance at this time. SEOC will continue to monitor the situation and maintain regular contact with the community.

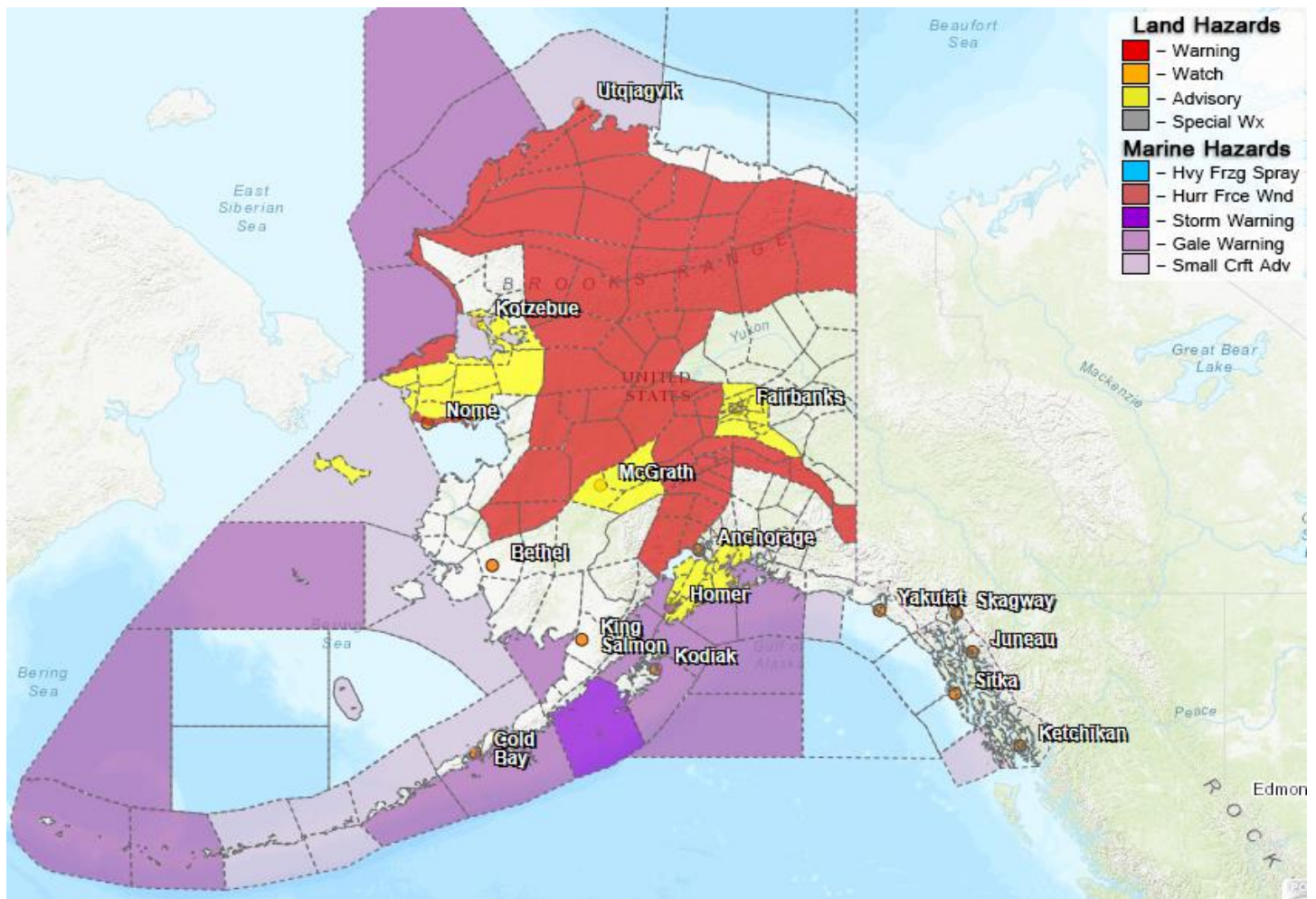

## Significant Weather:



A winter storm warning is in effect for the Susitna Valley, Denali, Southeastern Brooks Range, Upper Koyukuk Valley, Central Interior, Lower Yukon Valley, Lower Koyukuk and Middle Yukon Valleys, Upper Kobuk and Noatak Valleys, Western Arctic Coast, Northwestern Brooks Range, and the Northeastern Brooks Range.

A winter weather advisory is in effect for the Western Kenai Peninsula, Prince William Sound, Middle Tanana Valley, and the Upper Kuskokwim Valley.

A high wind warning is in effect for the Eastern Alaska Range and Denali.

A wind advisory is in effect for Deltana and Tanana Flats.

A coastal flood advisory is in effect for the Baldwin Peninsula and Selawik Valley, and the Northern and Interior Seward Peninsula.

A coastal flood warning is in effect for the Chukchi Sea Coast, Southern Seward Peninsula Coast, and the Northern Arctic Coast.

A high surf advisory is in effect for St. Lawrence Island and Bering Strait Coast, and the Western Arctic Coast.
