- 11 MAR 20 – Gov Dunleavy declares a Public Health Disaster Emergency.
- 14 MAR 20 – Gov Dunleavy Announces first confirmed case in Alaska.
- 20 MAR 20 – Gov Dunleavy Announces Alaska COVID-19 Economic Stabilization Plan. DHSS announces 12th confirmed case in state.
- 25 MAR 20 – First out-of-state death of an Alaska resident reported in Washington.
- 27 MAR 20 – First in-state death of an Alaska resident reported in Anchorage.
- 28 MAR 20 – Case count in-state exceeds 100.

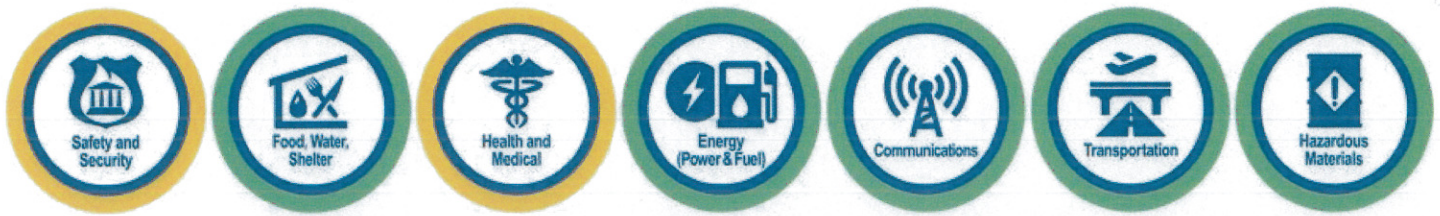

	 <p>Gov't Services</p>	<p>Health Mandate - School Closures: The State of Alaska (SOA) <u>Health Mandate 008</u> (3/20) dictates that all scheduled public-school days through May 1, 2020 will be non-student contact days in which students will not be attending school. Schools have begun deployment of distance learning.</p> <p>Child Care: DHSS is fielding questions from licensed providers. Guidance was published in the <u>SOA Health Alert 008</u> (3/17). Additional guidance will be provided as necessary.</p>
	 <p>Law Enforcement</p>	<p>Protective Measures – Law Enforcement: A number of communities have enacted additional screening requirements in addition to those outlined in the Governor’s Health Mandates.</p>
	 <p>Community Safety</p>	<p>Health Mandates - Social Distancing and Enforced Closure of Public Spaces: <u>SOA Health Mandate 011</u> (3/28) mandates all individuals cease gatherings with non-family members regardless of number of people present. This includes weddings, church or other faith-based gatherings, and graduations.</p> <p>Further the order mandates those that are ill or displaying symptoms of illness must remain home except to seek medical care as required.</p> <p>The order additionally required all non-governmental and non-critical infrastructure businesses to close, effective 5:00 p.m. on March 28 until further notice. Permissible activities for businesses during the closure are limited to defined minimum basic operations. The mandate will be reevaluated on April 11.</p>

Due to school closures, school lunch programs transitioned to alternative delivery. The SEOC is unaware of any current unmet needs.

Statewide Positive Case Count total: 143 current/9 hospitalized/3 deaths*

There are currently 143 confirmed cases in Alaska. Community-spread of the disease is occurring in Alaska.

Transportation



International & Interstate Travel:

SOA Health Mandate 010 (3/23) orders a mandatory 14-day self-quarantine for both international & interstate travelers (resident or non-resident) traveling to Alaska; failure to follow this order is punishable by the law.

Intrastate Travel:

SOA Health Mandate 012 (3/28) suspends all in-state travel unless necessary to support identified critical infrastructure or for identified critical personal needs.

The mandate also empowers small communities to enact more strict travel restrictions than outlined in the mandate provided they comply with state guidance.

US Canada Border Crossing

United States and Canada are temporarily restricting all non-essential travel across the ALCAN border. "Non-essential" travel includes travel that is considered tourism or recreational in nature.

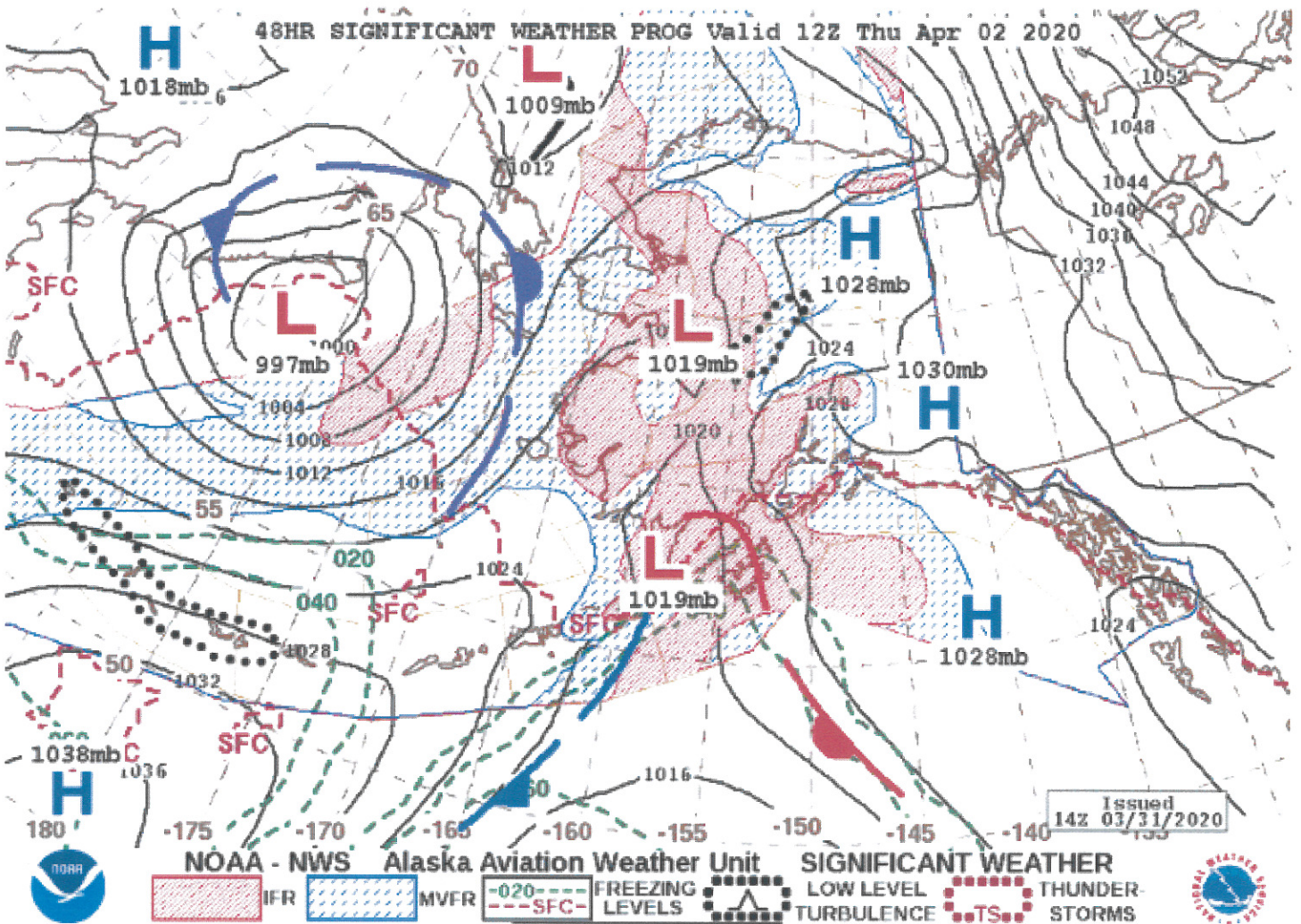
Snow is spreading from the SW late Wednesday night.
