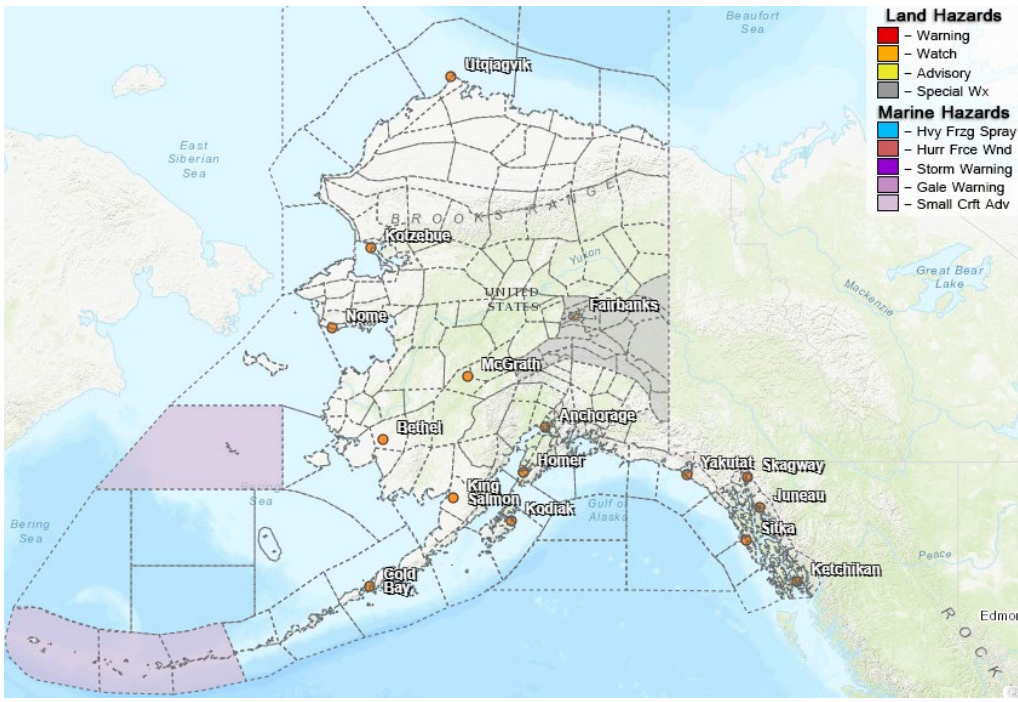

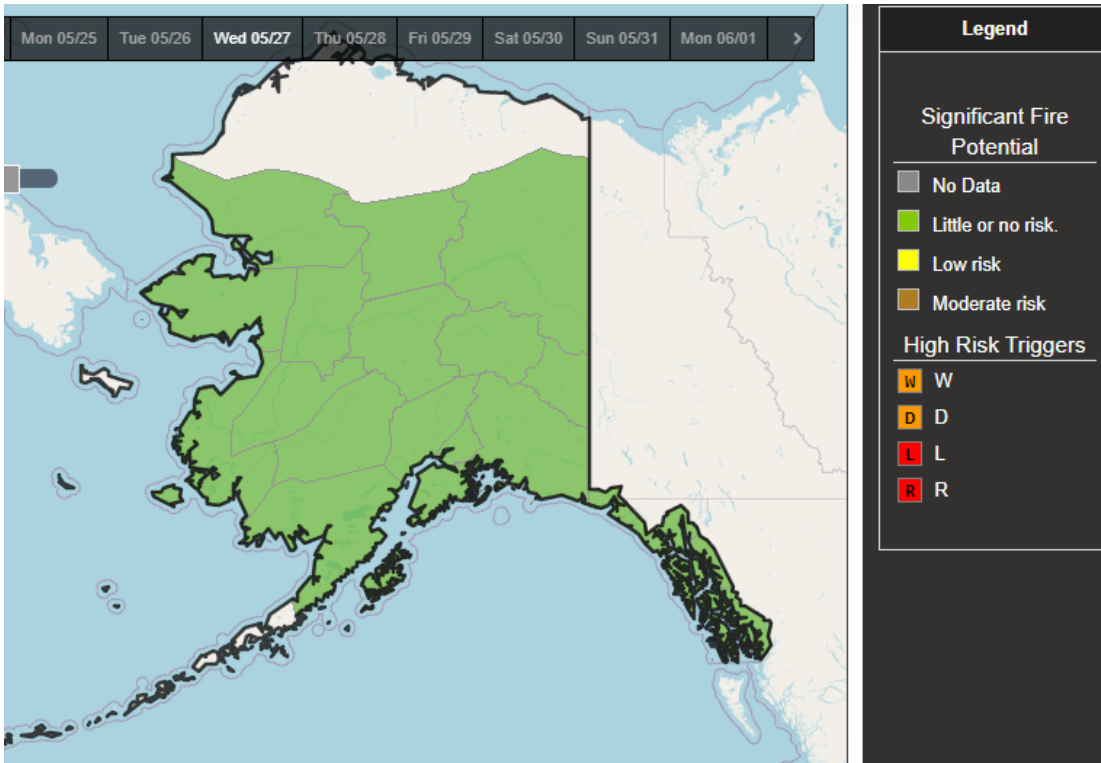
### **Significant Weather:**
