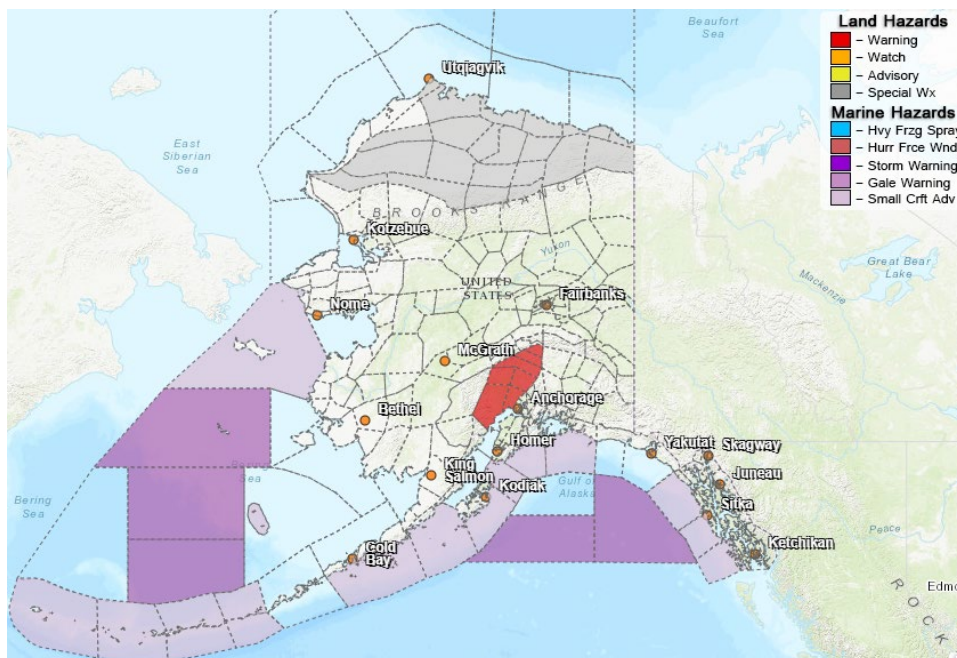

Significant Weather:

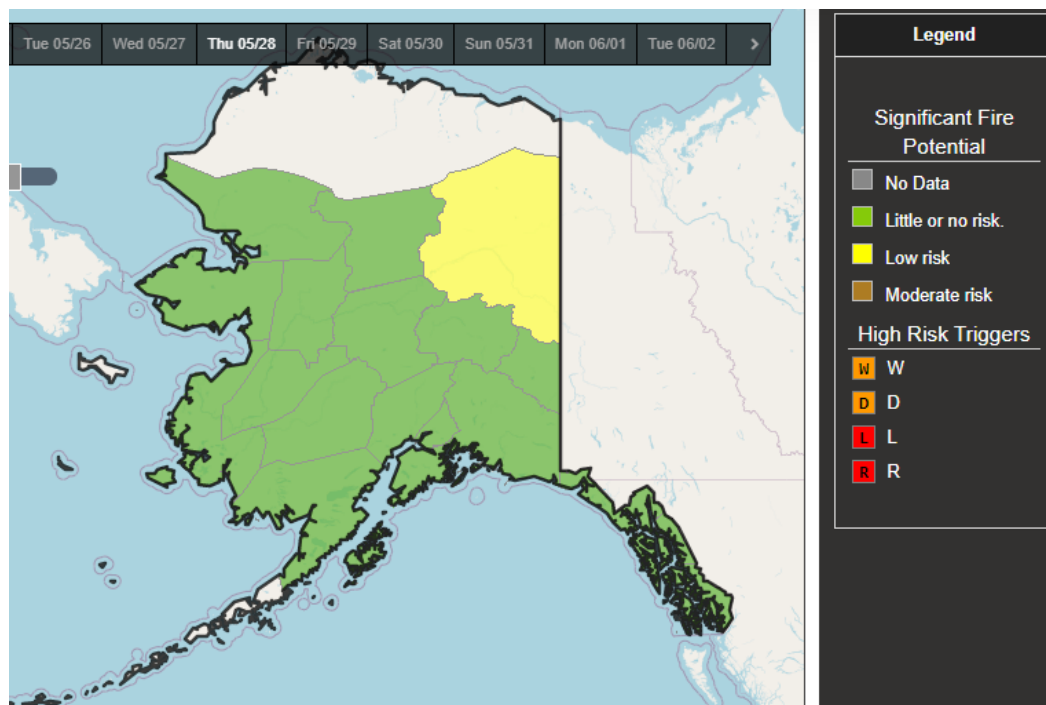


A special weather statement is in effect for breakup on the North Slope. Warm temperatures in the Brooks Range are causing rapid snow melt that will continue through this weekend. Rivers draining north such as the Colville, Kuparuk and Sagavanirktok rivers all have ice remaining near the coast, and could have ice jam issues near the coast this week as rising water levels move downstream towards the coast. Rivers near the Arctic Coast should be monitored closely for ice jams and potential flooding through this weekend across the Southern Interior and Alaska Range through Wednesday.

Fire Weather

A red flag warning is in effect for the Susitna Valley from 1 PM through 9 PM Thursday.
