Coronavirus (COVID-19) Pandemic

A unified command has been established at the SEOC. The SEOC Preparedness Level remains at Level 3 for this event.

2020 Fire Season

The Alaska Interagency Coordination Center, (AICC) is at Preparedness Level 1.

Wildland fire totals for 2020:

- Total Fires = 124
- Total Acres = 5,641

There are currently 37 active fires with 2 fires currently staffed.

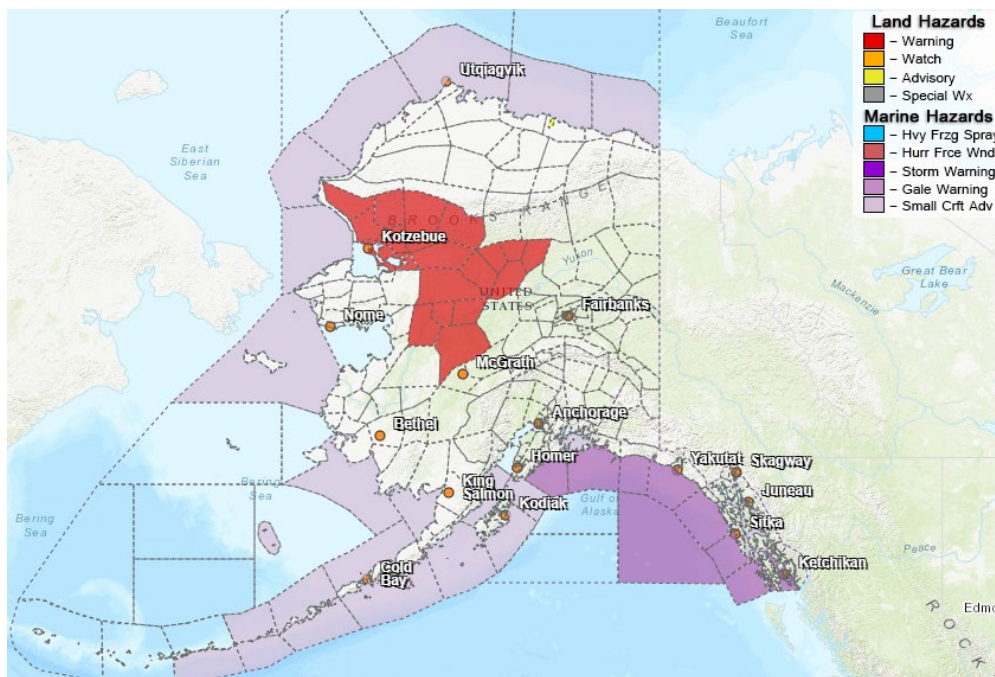

Significant Weather:

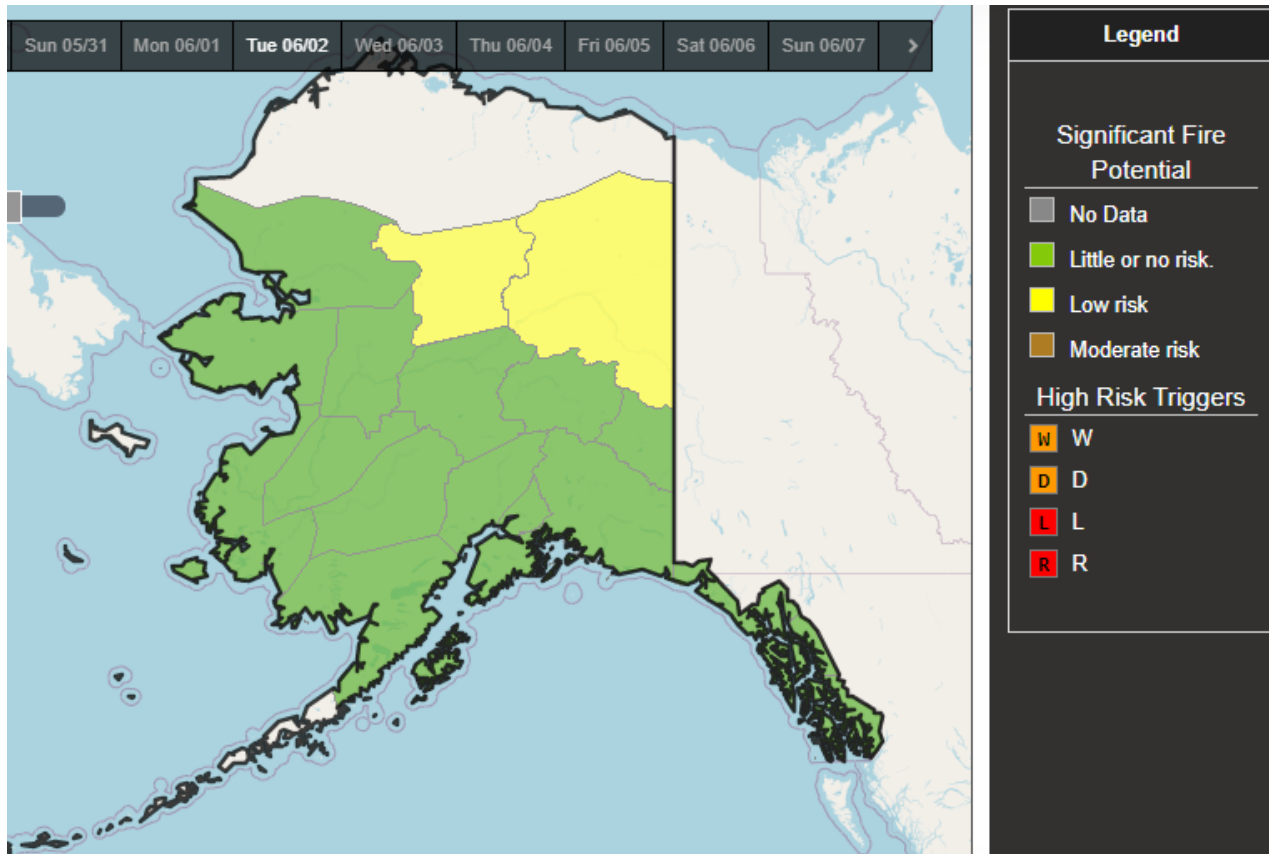


A flood advisory is in effect for the Kuparuk River near the Bridge until 8:15 AM Tuesday.
