A unified command has been established at the SEOC. The SEOC Preparedness Level remains at Level 3 for this event.

**2020 Fire Season**

The Alaska Interagency Coordination Center, (AICC) is at Preparedness Level 2.

Wildland fire totals for 2020:

Total Fires = 279  
Total Acres = 171,357

There are currently 98 active fires with 1 fire currently staffed.

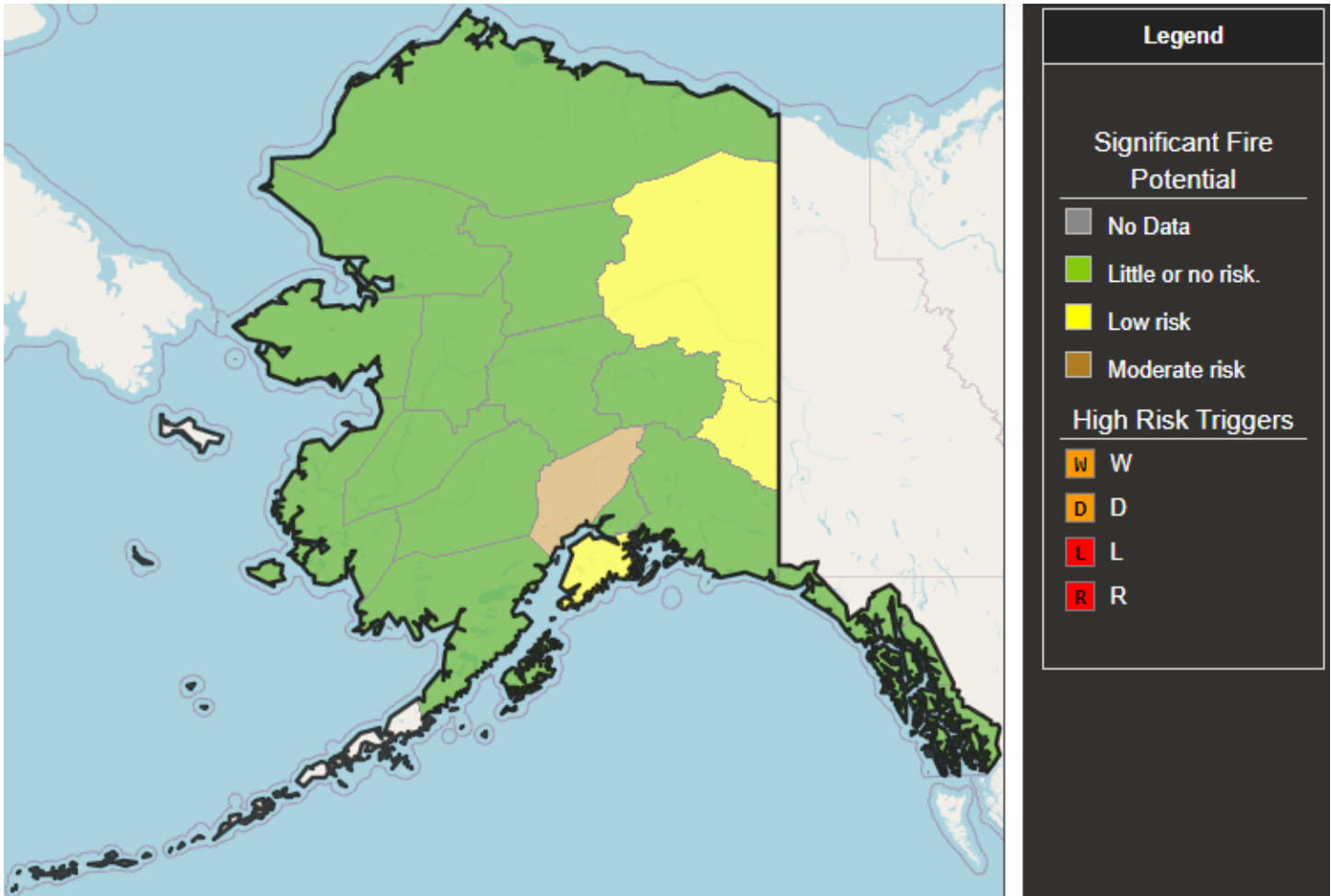
### **Significant Weather:**
