Significant Issues

SEOC Operations staff made follow up phone calls to multiple communities that were in the earthquake area from the 7.8 earthquake located south of Chignik from July 21 during the day yesterday to receive updates from community members about any potential damages. SEOC will continue to communicate with these communities while they collect damage assessment information.

Coronavirus (COVID-19) Pandemic

A unified command has been established at the SEOC. The SEOC Preparedness Level remains at Level 3 for this event.

2020 Fire Season

The Alaska Interagency Coordination Center, (AICC) is at Preparedness Level 1.

Wildland fire totals for 2020:

Total Fires = 309

Total Acres = 178,504

There are currently **50** active fires with **1** fire currently staffed.

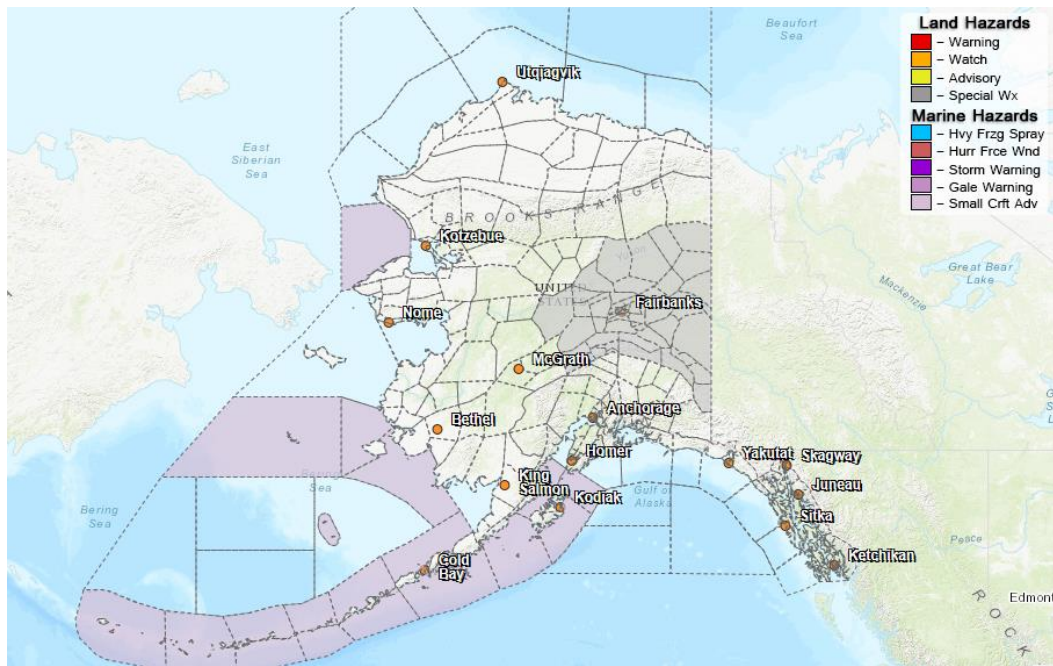

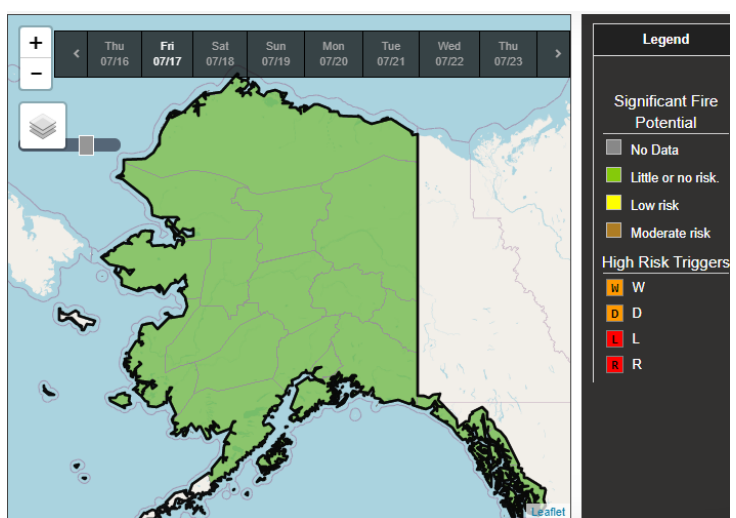
Significant Weather:



Special weather statement for heavy showers in the Alaska Range, Central and Eastern Interior. A front currently over the North Slope is expected to continue pushing south over the Brooks Range and into the Central and Eastern Interior regions later today. The front is expected to stall over the Alaska Range through the weekend. Rainfall totals are predicted to be between half an inch to 1 and half inches of rain in these areas through Sunday.
