Significant Issues

Chignik 7.8 Earthquake

The SEOC continues to collect damage assessments from local residents in multiple communities that have reported damages from the magnitude 7.8 earthquake on July 22. The SEOC is also in communication with the Lake and Peninsula Borough as well as the Aleutians East Borough for further assessments.

Delta River Flooding

DOT&PF continues to work to divert water from the road way while they evaluate river conditions to determine a long term solution of redirecting water flow. The SEOC will continue to monitor the situation and be in contact with DOT&PF for further updates.

Coronavirus (COVID-19) Pandemic

A unified command has been established at the SEOC. The SEOC Preparedness Level remains at Level 3 for this event.

2020 Fire Season

The Alaska Interagency Coordination Center, (AICC) is at Preparedness Level 1.

Wildland fire totals for 2020:

Total Fires = 311

Total Acres = 180,157

There are currently 50 active fires with 0 fires currently staffed.

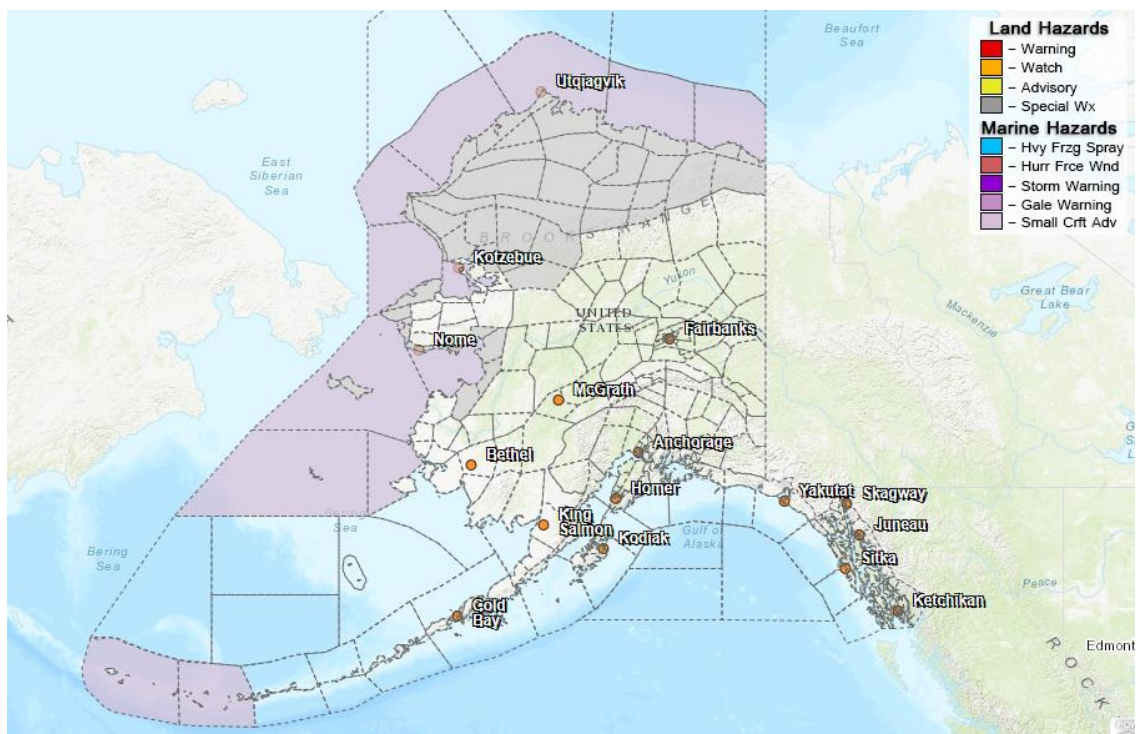

Special weather statements are in effect through this evening for the Northern Arctic and Western Arctic Coast, as well as the Central and Eastern Beaufort Sea coast, Northwestern and Northeastern Brooks Range for heavy rain of 1/2 an inch to 1 1/2 inches of rain, the heaviest rain fall is expected along the north slopes of the Brooks Range. Additional weather statements have been issued for heavy rain in the lower and upper Kobuk and Noatak Vallys for heavy rain through Tuesday.
