Total Acres = 181,212

There are currently 22 active fires with 0 fires currently staffed.

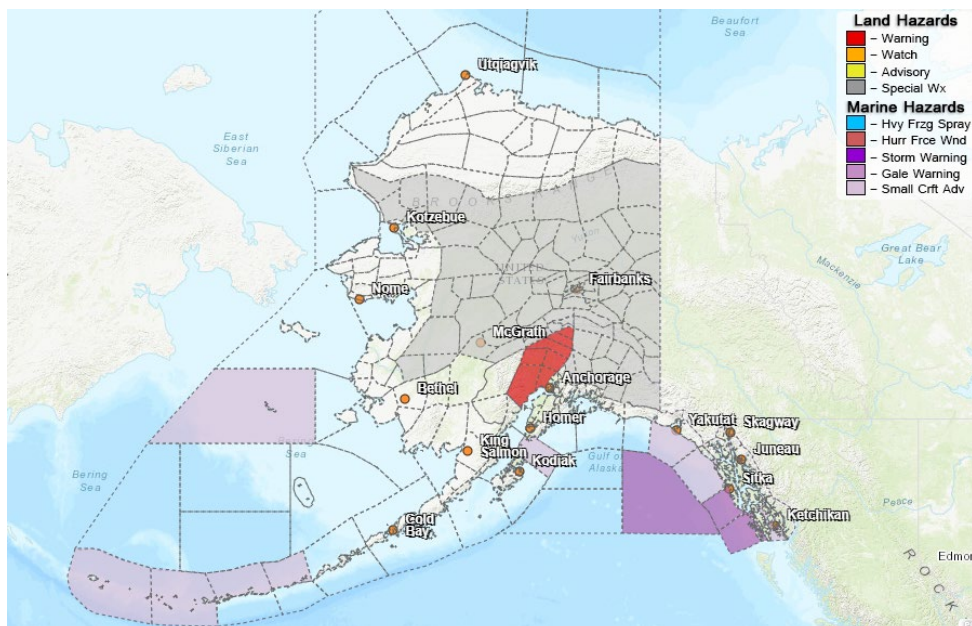
