A unified command has been established at the SEOC. The SEOC Preparedness Level remains at Level 3 for this event.

Total Acres = 181,688

There are currently **22** active fires with 0 fires currently staffed.

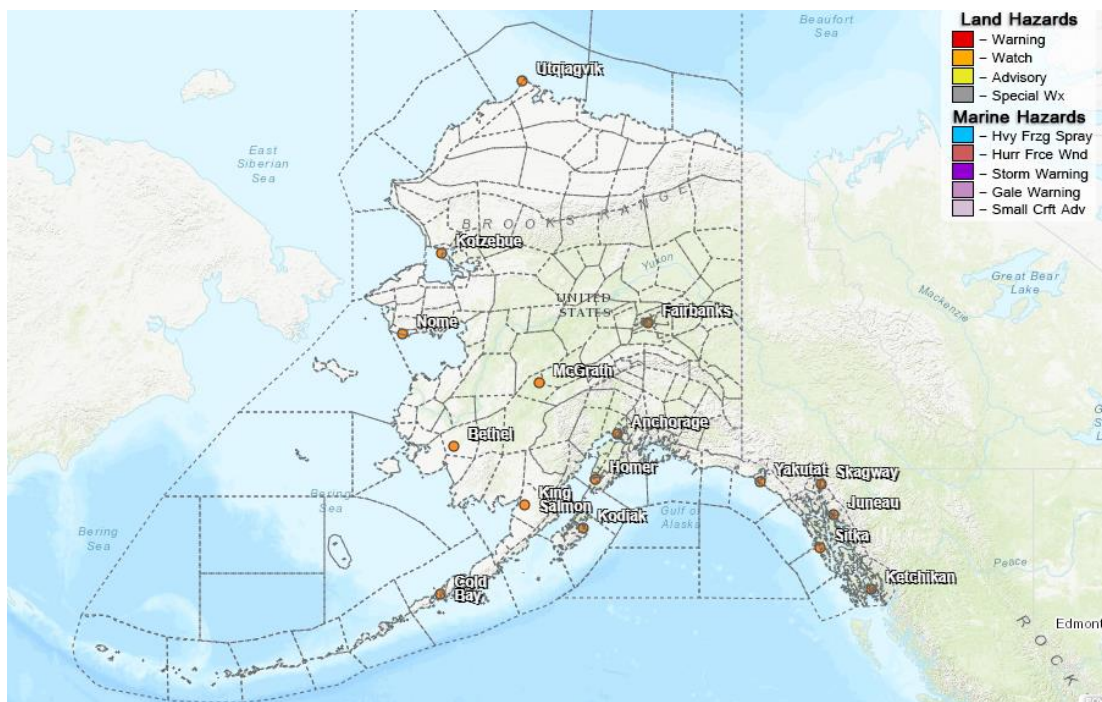
