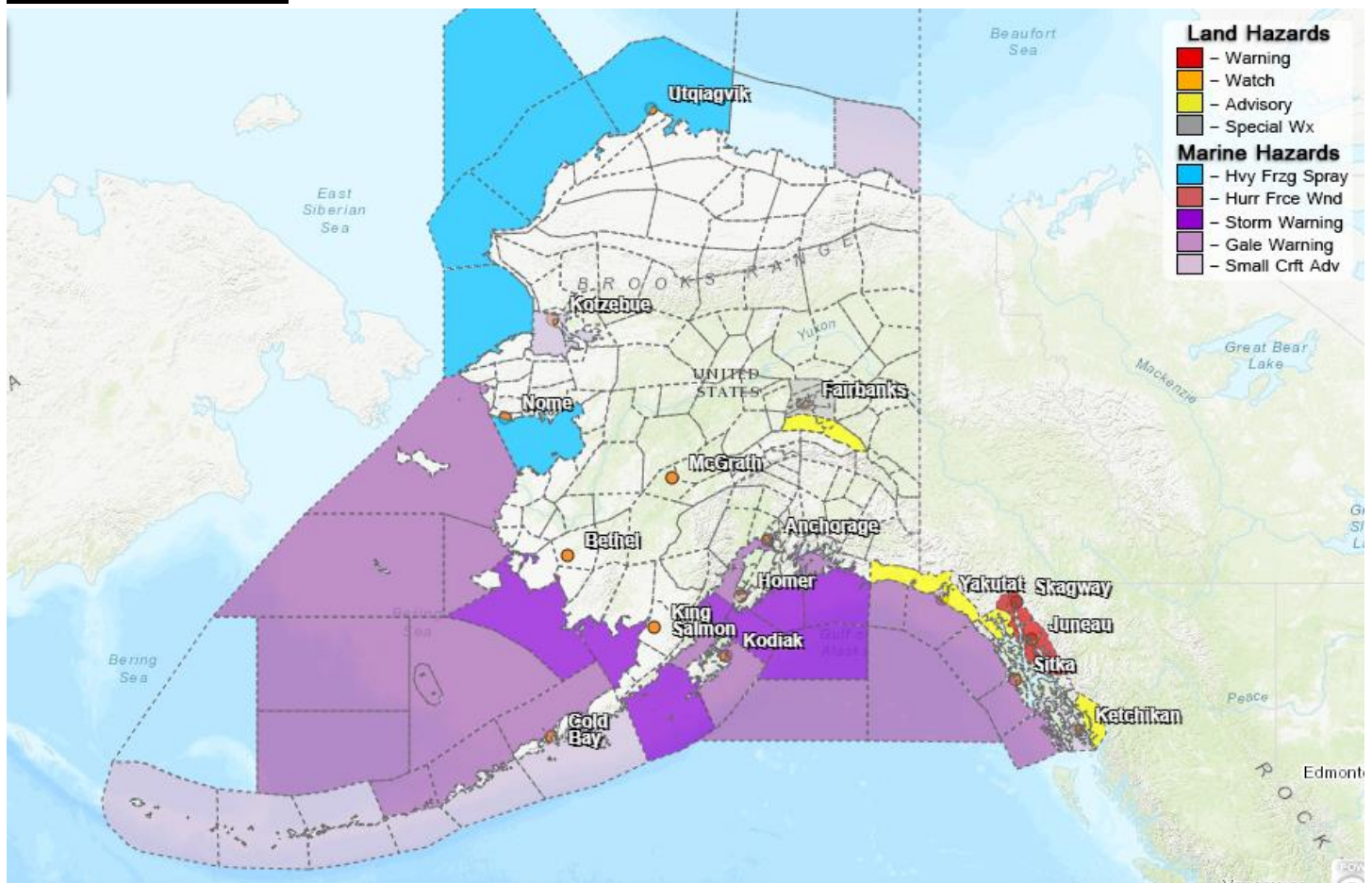
Air Quality Index (AQI) Advisories

Significant Weather:



A Winter Weather Advisory has been issued for Glacier Bay beginning tomorrow at 6:00 A.M. and lasting until 6:00 P.M. Glacier Bay and Gustavus are forecasted to receive 3 to 7 inches of snow accumulation.

A Winter Storm Warning has been issued for the Haines Borough, Juneau Borough, and the Klondike Highway beginning tomorrow at 8:00 A.M. and lasting until 9:00 P.M. Heavy snow is expected with accumulations of 4 to 11 inches.

A Winter Weather Advisory has been issued for Misty Fjords and Hyder beginning at 10:00 A.M. tomorrow and lasting until 11:00 P.M. Snow accumulations of 6 to 10 inches are expected throughout the area.

A Winter Weather Advisory has been issued for the coastal area from Cape Fairweather to Cape Suckling beginning at 8:00 A.M. tomorrow and lasting until 5:00 A.M. Sunday. Snow accumulations of 4 to 7 inches with winds gusting as high as 40mph are expected.

A High Wind Advisory is in effect until 6:00 P.M. Saturday for Deltana and Tanana Flats. Winds of 25 to 35 mph with gusts to 55mph are forecasted for the area.
