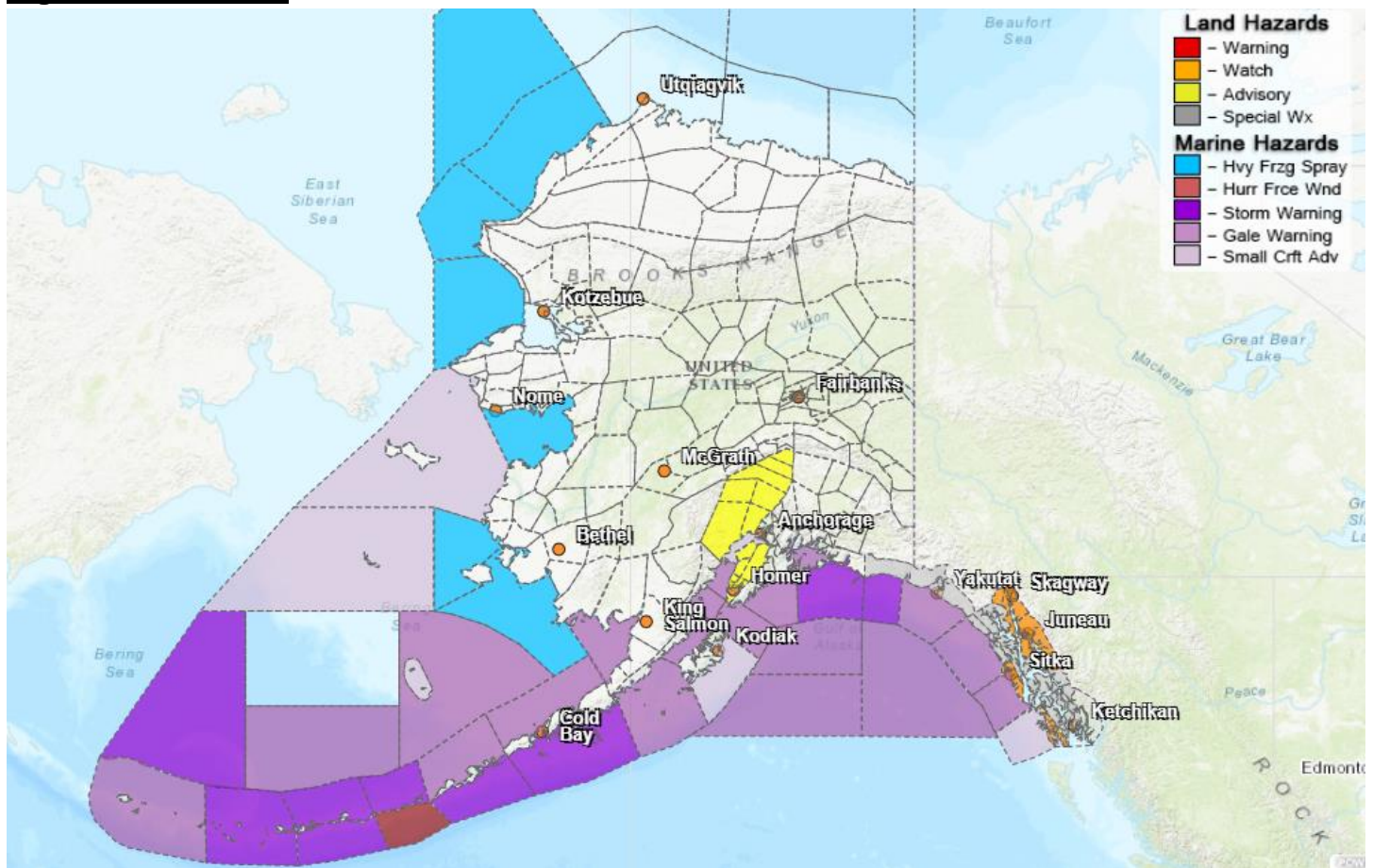

A Winter Weather Advisory is in effect for the following areas:

- Western Kenai Peninsula from the City of Kenai to the East until 6pm Friday evening for snow accumulation of 6-12 inches expected.
- Susitna Valley west of the parks Highway until 6pm Friday evening for snow accumulation of 6-12 inches.

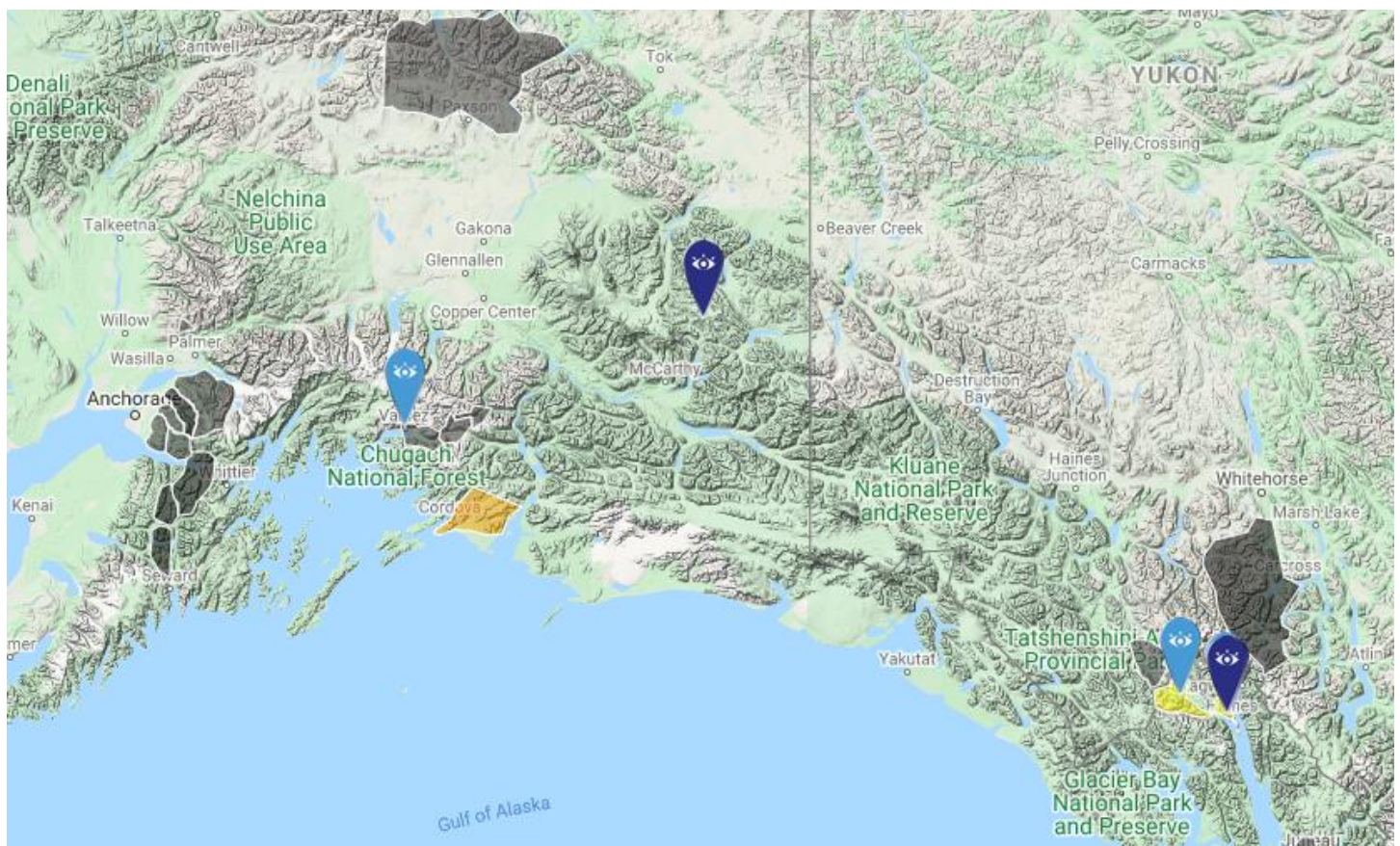
A High wind Watch is in effect from Saturday morning through Saturday afternoon for Baranof Island including Juneau, Sitka and Port Alexander, south winds 35 to 45mph with gusts up to 60mph are possible.

A Winter Storm Watch is in effect from Saturday morning through Sunday evening for the Haines Highway, Klondike Highway, and Haines for heavy snow accumulation of 5 to 9 inches.

A Special Weather Statement is in effect for very windy conditions Saturday into Saturday night. Gusty strong winds of 40 to 55mph are possible in the areas of Juneau, Sitka and the Western Prince of Wales Island.
