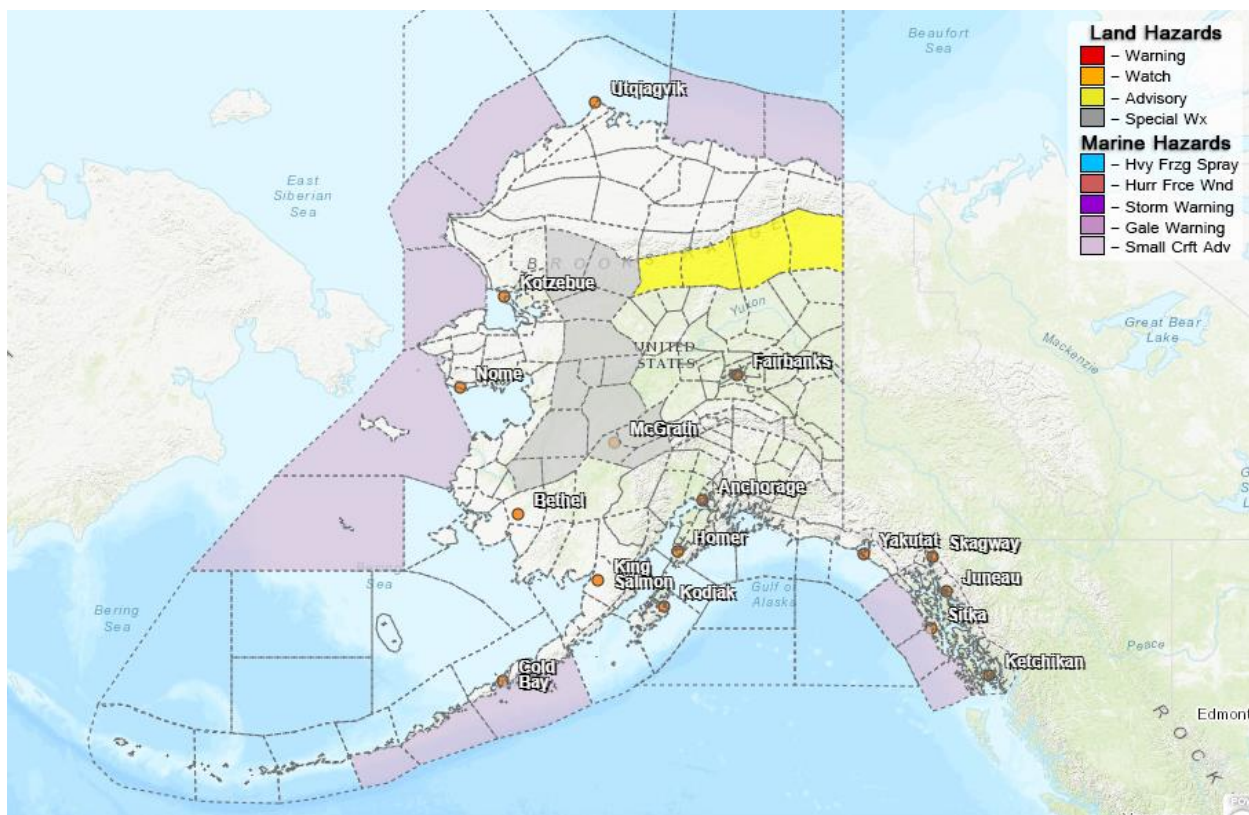

A Special Weather Statement has been issued for the Western Interior. Significant rainfall is expected throughout today into tonight. This will cause a sharp rise in rivers in the area later this week.

A Winter Weather Advisory remains in effect for the Southeastern Brooks Range until 10:00 A.M. today. An additional 1 to 2 inches of snow is expected at elevations above 3000 feet.
