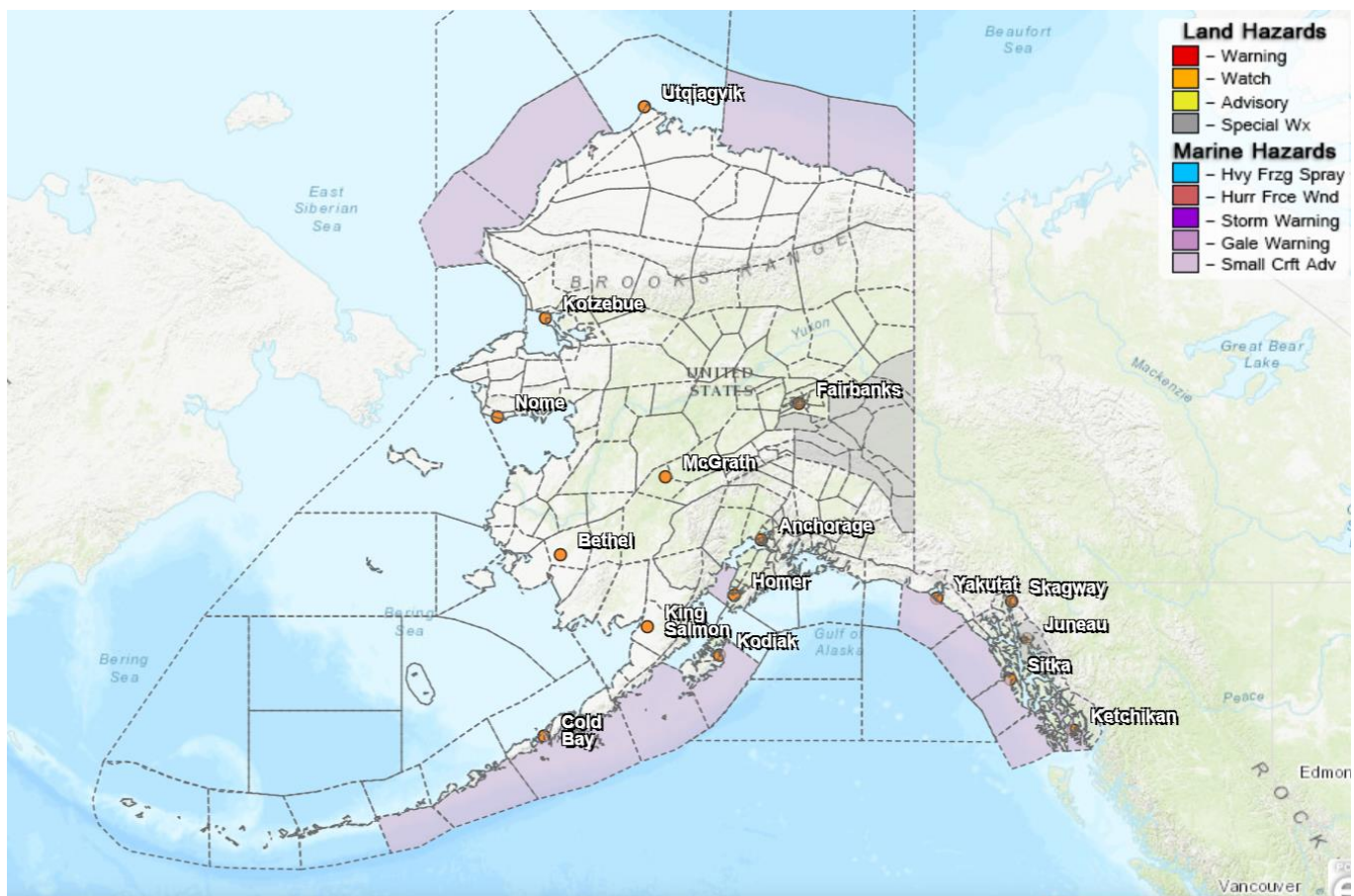

Significant Weather:



A Flood Advisory is in effect for the Juneau Borough and Northern Admiralty Island until 10:00 A.M. today. Jordan Creek and the Central Inner Channels have elevated water levels due to increased rainfall over the past 24hrs. Minor flooding is possible in the area of Jordan Creek.

A Special Weather Statement has been issued for the Eastern Alaska Range in the area of Dot Lake and Chicken. Heavy rain is expected today into tomorrow and minor flooding is possible along streams and small rivers in the area.
