Significant Issues:

Kasikluk Fire

The SEOC remains in contact with the community of Kasigluk after a fire yesterday damaged the Akiuk Memorial School, teacher housing and other structures in the community. The Alaska Division of Forestry deployed multiple aircraft and smokejumpers to assist the community with their firefighting efforts. The fire is reportedly under control as of yesterday evening and there have been no reported injuries.

Lowell Point Landslide

Lowell Point Road is expected to reopen to traffic at noon today for the weekend. This will be followed by intermittent closures to continue debris clearing and repairs next week.

River Watch 2022

The 2022 Spring Floods, the 2022 Lowell Point Landslide in the City of Seward, and the Galena Fire Hall roof collapse will now be eligible for State of Alaska disaster recovery programs. Individuals and families can now apply for state disaster grants. See <https://ready.alaska.gov/> for details.

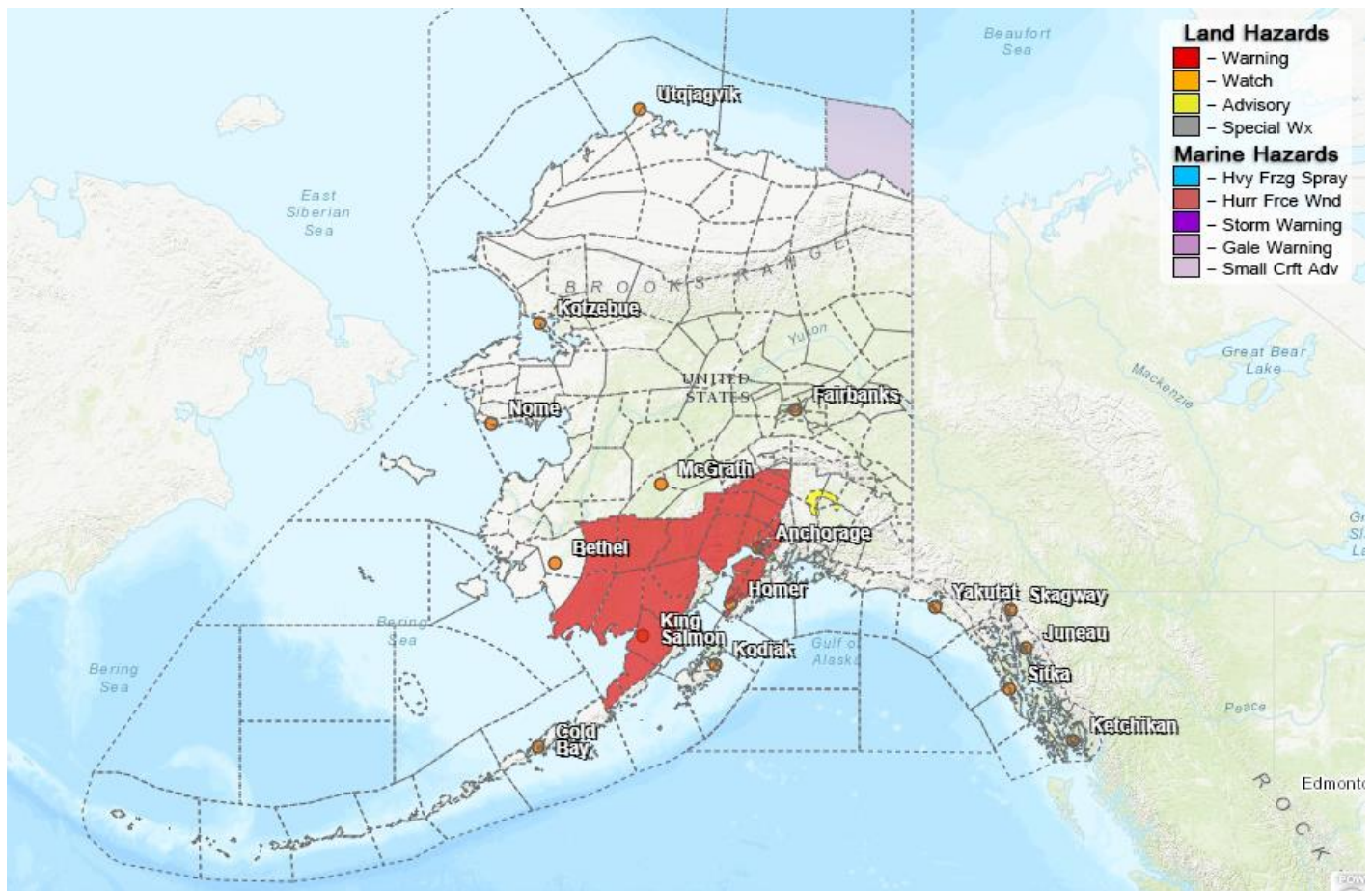

Flood Advisories remain in effect for the following areas:

- Copper River Basin – Snowmelt flooding continues along the Gulkana River and Lake Louise Road. The advisory expires on **June 2nd**.
- Shageluk – Minor flooding on the Innoko River is expected until 10:00 A.M. **tomorrow**.

Fire Weather:

- A red flag warning has been issued for Anchorage, Bristol Bay, Matanuska-Susitna Valley, Middle Kuskokwim Valley, Western Alaska Range and the Western Kenai Peninsula. Low humidity, warm temperatures and gusty wind conditions are forecasted for the region until 10:00 P.M. today.

Burn permits remain suspended for most of south central and the southern interior due to high fire risk conditions.
