### Significant Issues:

#### Moose Glacier Outburst

SEOC is reviewing the signed local disaster declaration from the Kenai Peninsula Borough late last week regarding the glacier outburst flooding event. The SEOC will continue to be in contact with the KPB EOC to identify damaged infrastructure, public and private property.

#### Talkeetna High Water

The SEOC remains in contact with the Matsu Borough EOC regarding the local disaster declaration that was received last week. MSB OEM and SEOC are working to identify public infrastructure impacts and associated costs for damaged infrastructure, as well as identifying the incident timeline.

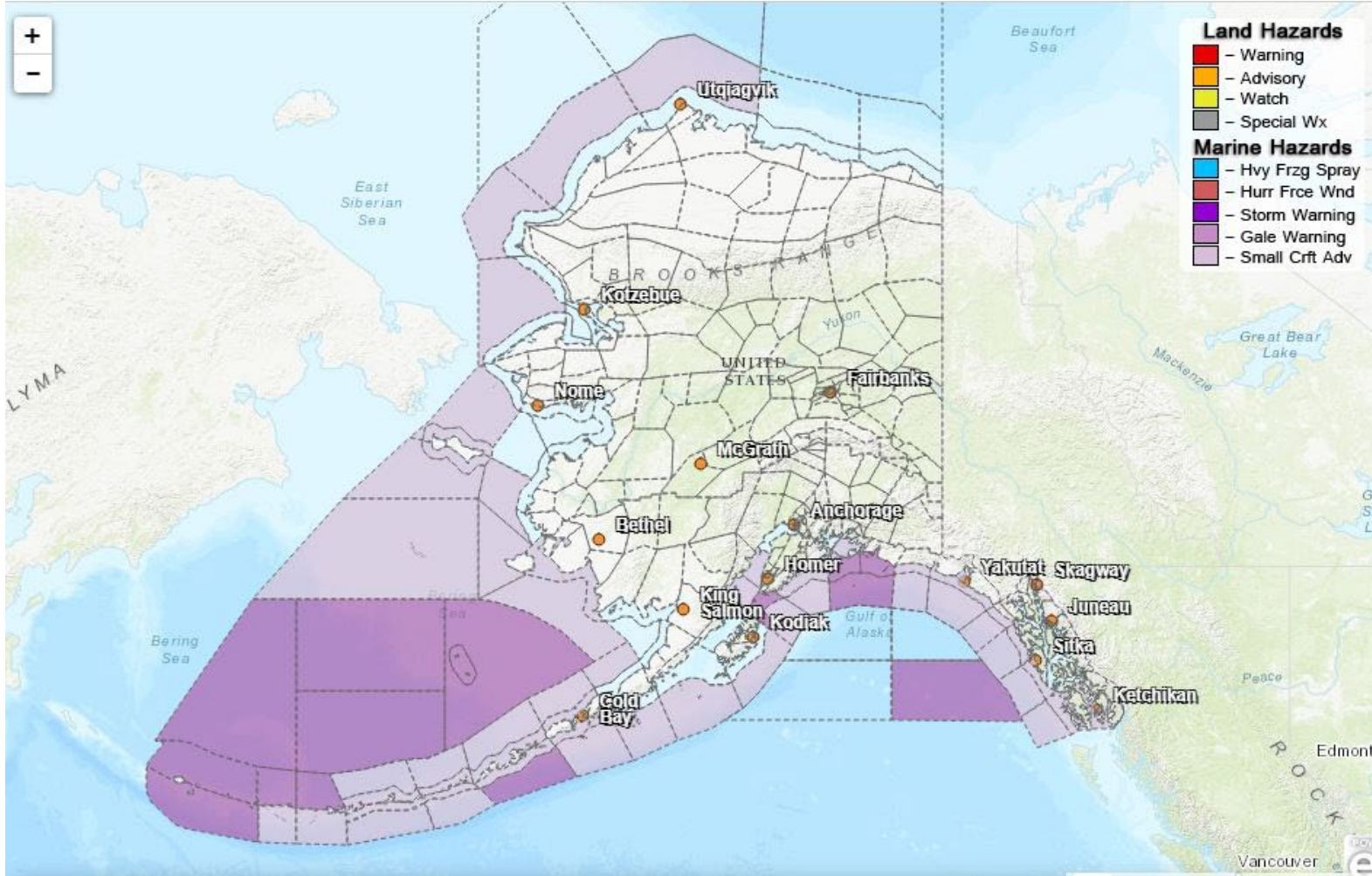
