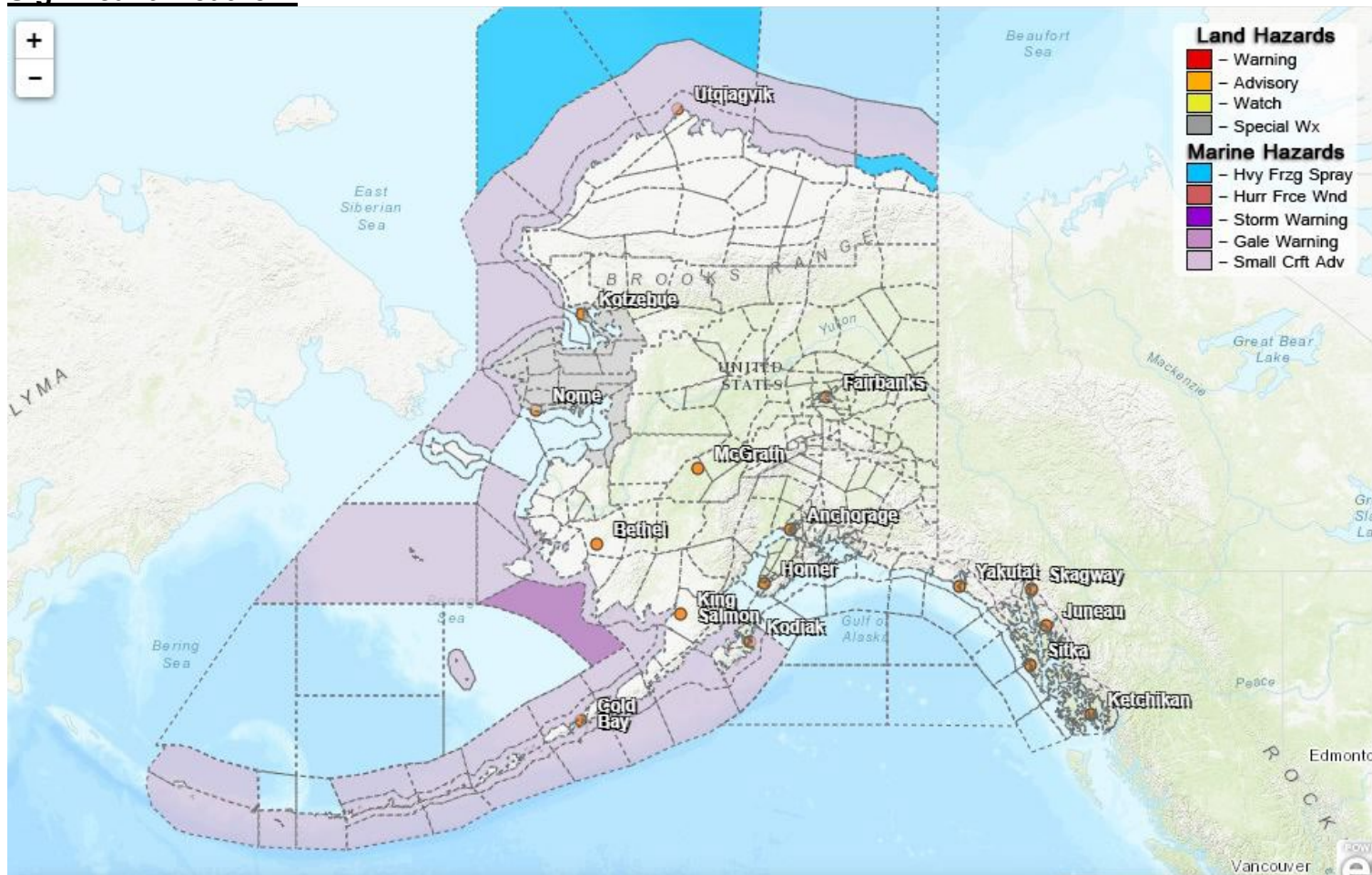

Special weather statement for the Lower Kobuk Valley; Baldwin Peninsula; Northern Seward Peninsula; Shishmaref; Bering Strait Coast; Southern Seward Peninsula Coast; Interior Seward Peninsula; Eastern Norton Sound and Nulato Hills for mixed precipitation expected into Saturday. 1 to 3 inches of snow is possible and the potential for a glaze of ice. Strong southeast winds could also produce elevated surf in the Bering Strait Friday into Saturday.
