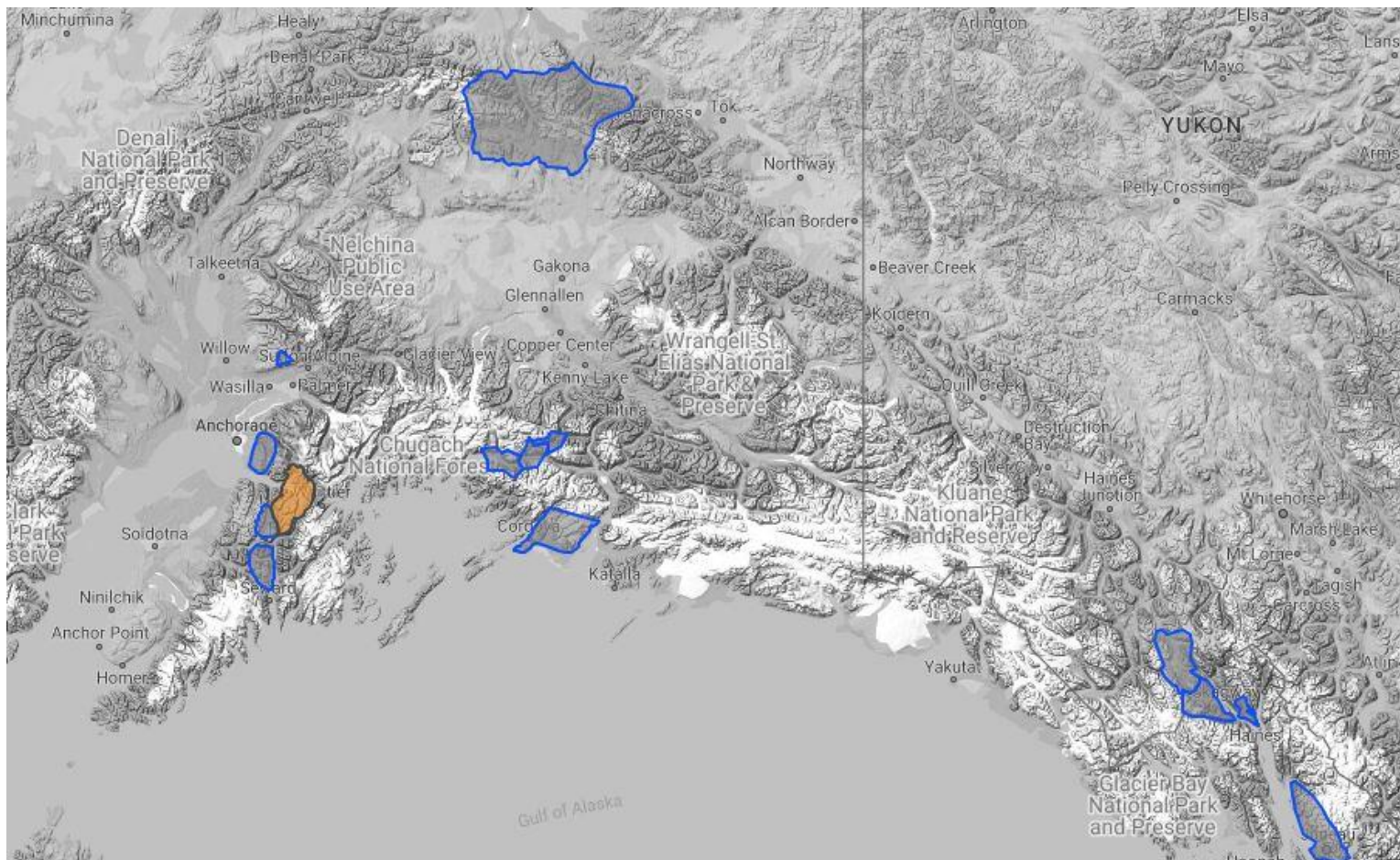

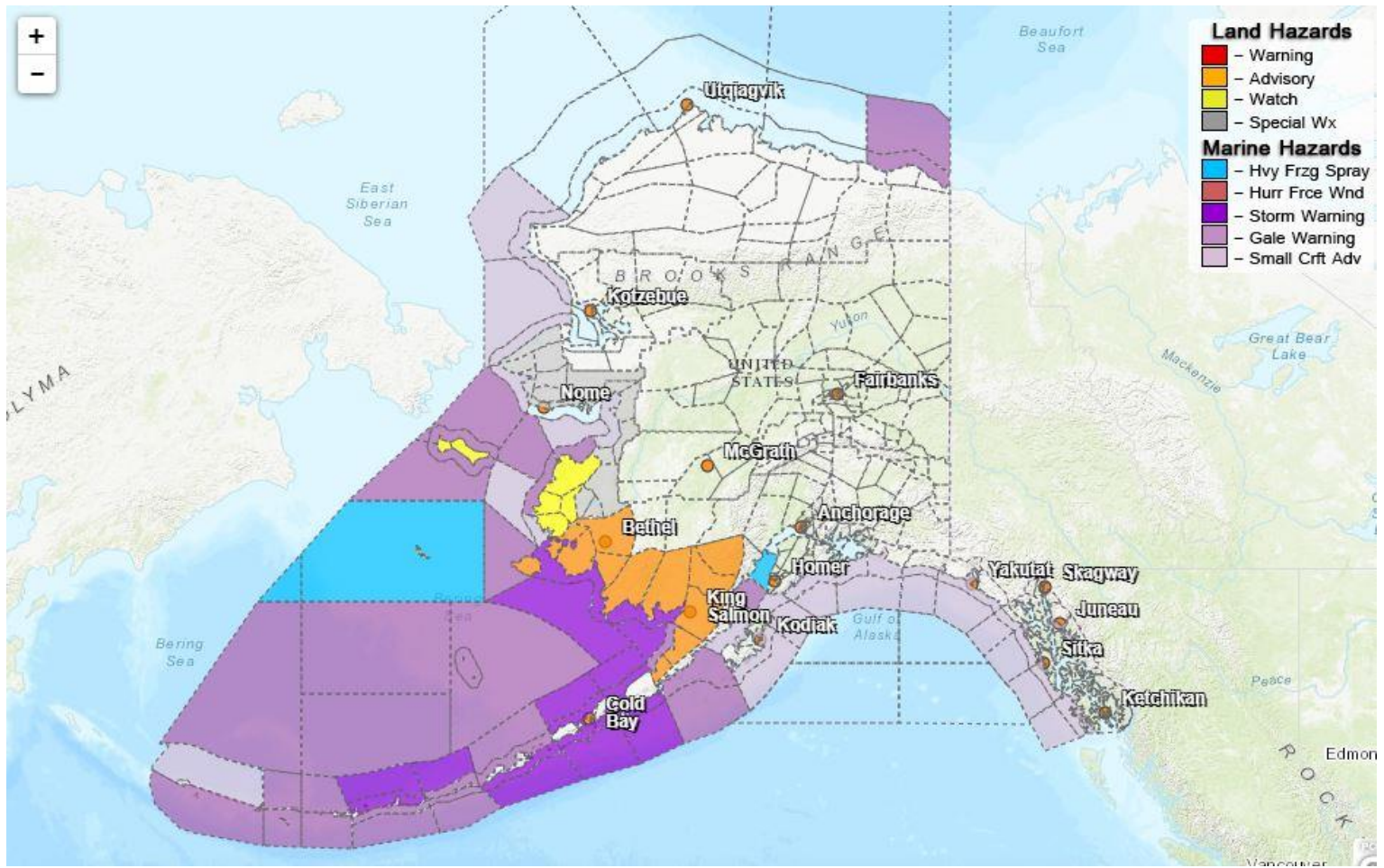
Avalanche Hazards:
