

National Weather Service, (NWS) Fairbanks AK has issued a high wind Advisory for Deltana and Tanana Flats, the Eastern Alaska Range. The advisory is in effect from 6 PM this evening to 6 PM AKDT Tuesday.

The NWS Anchorage has issued a Dense fog advisory for the Western Kenai Peninsula. The advisory is in effect UNTIL 10 AM akdt this morning near cook inlet.

Additionally, the NWS Anchorage has issued High Wind Warning for Kiska to Attu. They are forecasting a South wind 35 kt increasing to 65 kt in the afternoon. Seas 11 ft building to 24 ft in the afternoon.
