


# **Diomede Water System Freeze up**

The SEOC continues to monitor the developing water disruption in Diomede. Two Remote Maintenance Workers (RMWs) from Norton Sound Health Corporation (NSHC) were supposed to arrive Wednesday, but were unable to reach the island due to poor weather. The weather may improve on Friday per the NWS extended forecast. The situation in Diomede is not improving and it appears now that the water plant and community water tank are both frozen. The island has been without water supply since Saturday. The Division of Community and Regional Affairs is checking with ANTHC, Norton Sound Health Corporation, and Kawerak to determine their bottled drinking water supplies.


