

## **DHS&EM OPERATIONS**

#### High Water and Erosion Issues on the Koyukuk River

SEOC continues to monitor reports of high water, minor flooding, and/or erosion in the following communities: Akiak, Allakaket, Bettles, Hughes, and Huslia. The communities have taken action, including moving property to high ground and disconnecting utilities, to reduce loss.

#### **Tuluksak Power Outage**

The Alaska Energy Authority (AEA) and local utility staff are restoring power service in Tuluksak this week. Power has been intermittent due to worn parts and contaminated generator fuel.

#### Kwethluk and Akiak River Erosion

The National Resource Conservation Service is sending staff to Kwethluk and Akiak to evaluate the riverbank erosion for possible inclusion in their <a href="Emergency Watershed Protection Program">Emergency Watershed Protection Program</a>. The National Weather Service forecasts the water levels on the Kwethluk and Kuskokwim Rivers will continue to drop, which should lessen the erosion rate. The SEOC will follow up with the community today.

#### Cook Inlet M7.1 Earthquake (FEMA Declaration 4413-DR)

DHS&EM, FEMA, and other federal agencies are managing the recovery efforts associated with the Cook Inlet M7.1 earthquake at the Joint Field Office (JFO) in Anchorage.
