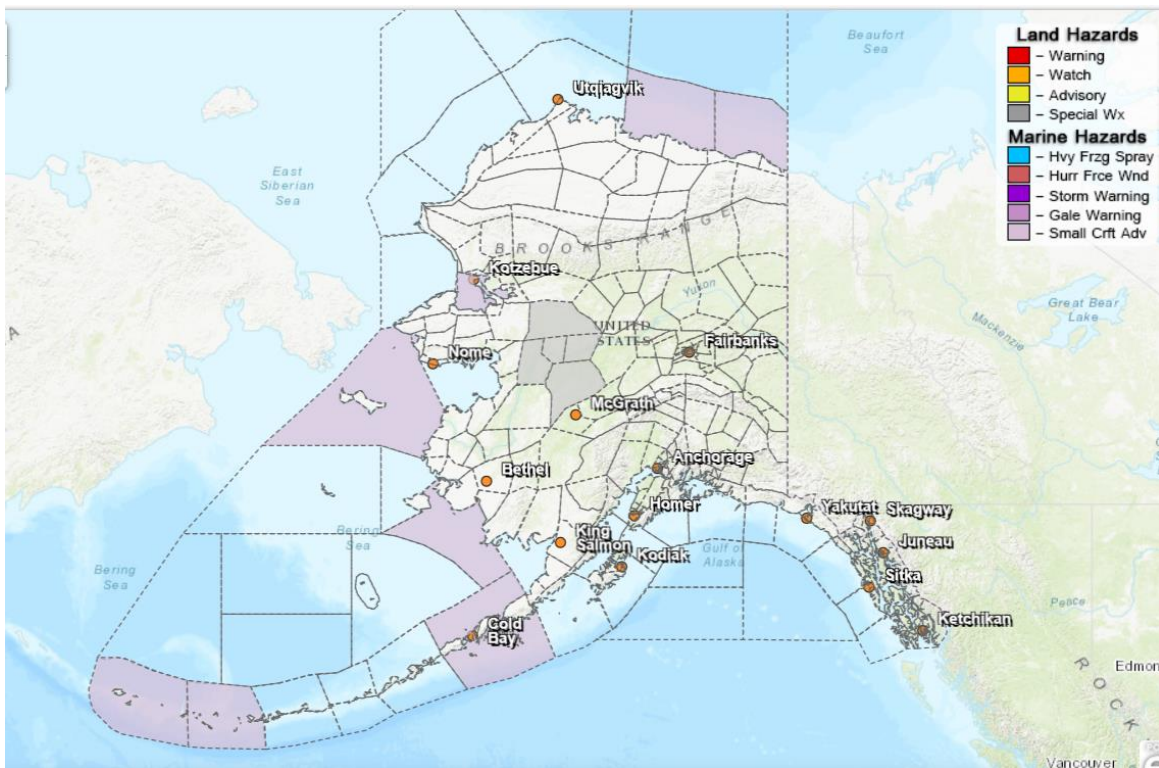
#### **Huslia Erosion and Flooding**

Tanana Chiefs Conference shipped out 1,000 sandbags, 50 pairs of work gloves, and other essential items to Huslia this past weekend. The community reports they are preparing to move five threatened structures to safer locations. The SEOC has been in contact with Huslia and has also reached out to the Alaska VOADs, Red Cross, Salvation Army, Tanana Chiefs Conference, and the Fairbanks North Star Borough for their assistance. The SEOC will continue to monitor their situation and provide support where possible.

#### **Cook Inlet M7.1 Earthquake (FEMA Declaration 4413-DR)**

DHS&EM, FEMA, and other federal agencies are managing the recovery efforts associated with the Cook Inlet M7.1 earthquake at the Joint Field Office (JFO) in Anchorage.
