THREAT LEVEL CHANGES: SEOC LEVEL 2 – HEIGHTENED AWARENESS

Significant Issues:

SEOC has gone to Level 2 – Heightened Awareness in support of the increased wildland fire operations in the state.

Over the weekend SEOC worked with multiple communities, state forestry, volunteer agencies, and the Alaska National Guard to support wildland fire operations.

2019 Fire Season

The Alaska Interagency Coordination Center, (AICC) is at Preparedness Level 3.

Wildland fire totals for 2019:

- Total Fires = 659
- Total Acres = 2,496,773 There are currently 237 active fires with 6 fires currently staffed.

Special Weather Statements and Flood Advisories have been issued through this afternoon for minor flooding of the Nenana River, the Tanana River, the Upper Chena River and the Salcha River due to heavy rains last week.

A Flood Warning has been issued through Tuesday morning to the Deltana and Tanana Flats and the Middle Tanana Valley for minor flooding of the Salcha River.
