

## Significant Weather:



A wind advisory is in effect for the Lower Yukon Valley, Lower Koyukuk and Middle Yukon Valleys, and the Upper Kobuk and Noatak Valleys.

A high wind warning is in effect for St. Lawrence Island and the Bering Strait Coast. A winter storm warning is in effect for the Eastern Alaska Range, Upper Tanana Valley and the Fortymile Country, Upper Koyukuk Valley, Yukon Flats and Surrounding Uplands, and the Central Interior.

A winter weather advisory is in effect for the Taiya Inlet and Klondike Highway, Copper River Basin, Deltana and Tanana Flats, and the Middle Tanana Valley.

A winter storm warning is in effect for Anchorage, Matanuska Valley, Western Kenai Peninsula, Susitna Valley, Eastern Alaska Range, Upper Tanana Valley and the Fortymile Country, Upper Koyukuk Valley, Yukon Flats and Surrounding Uplands, and Central Interior.

A blizzard warning is in effect for Northeast Prince William Sound.

A Wind Advisory is in effect for the Lower Yukon Valley, Lower Koyukuk and Middle Yukon Valleys, and the Upper Kobuk and Noatak Valleys.
