

A Blizzard Warning is in effect until tomorrow morning for the Pribilof Islands.

A High Wind Warning is in effect through Saturday for the Alaska Peninsula and the Eastern Aleutians.

Several Winter Storm Warnings, Watches, and Advisories are in effect for most of Western Alaska, the northern Interior, and the Alaska Range.

Wind Chill Advisories are in effect in many locations in Western Alaska.

A Dense Fog Advisory is in effect this morning for portions of the Panhandle.
