A unified command has been established at the SEOC. The SEOC Preparedness Level remains at Level 3 for this event.

2020 Fire Season

The Alaska Interagency Coordination Center, (AICC) is at Preparedness Level 3.

Wildland fire totals for 2020:

Total Fires = 238

Total Acres = 116,864

There are currently 115 active fires with 10 fires currently staffed.

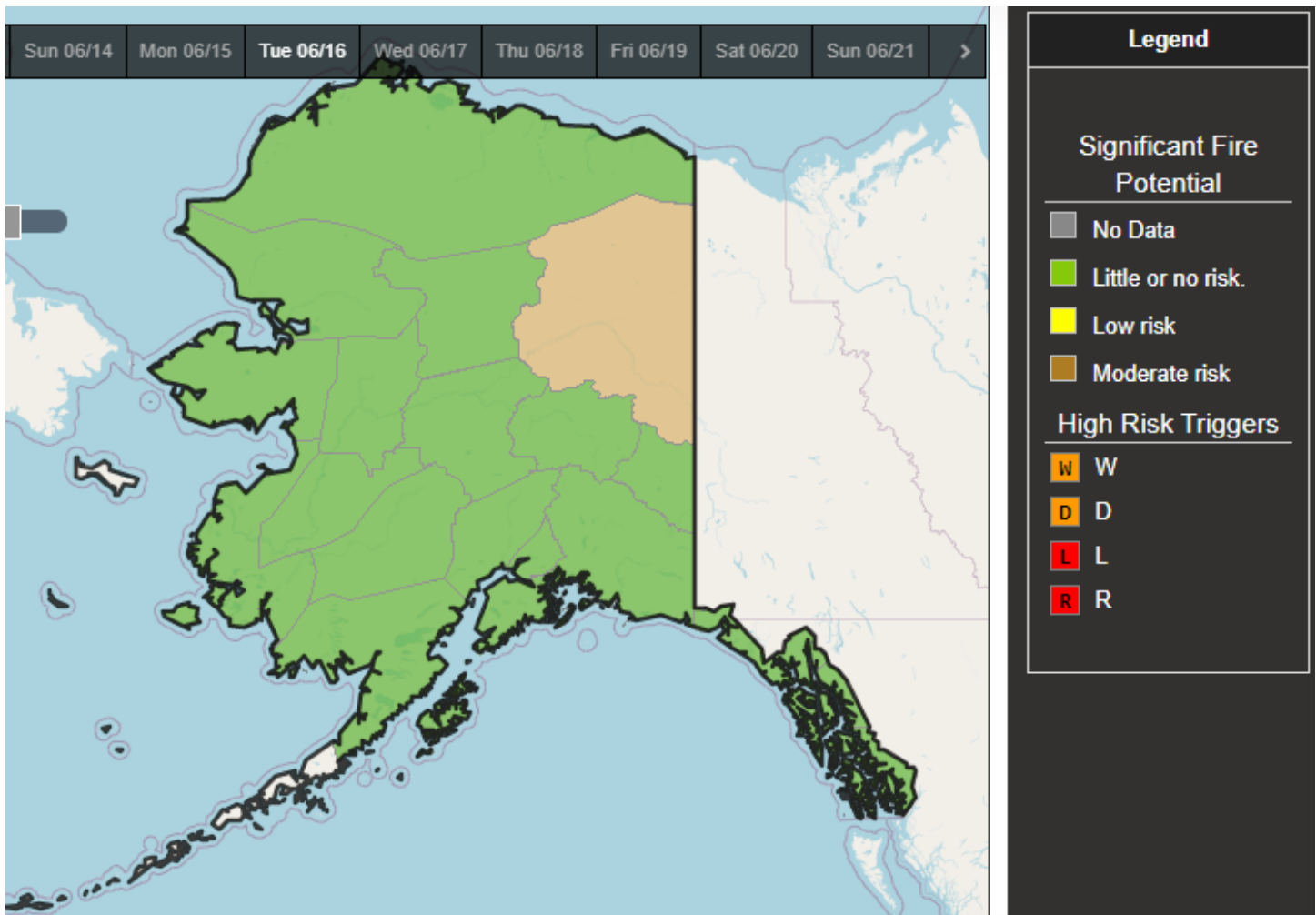
