A unified command has been established at the SEOC. The SEOC Preparedness Level remains at Level 3 for this event.

2020 Fire Season

The Alaska Interagency Coordination Center, (AICC) is at Preparedness Level 1.

Wildland fire totals for 2020:

Total Fires = 305

Total Acres = 175,579

There are currently 75 active fires with 4 fire currently staffed.

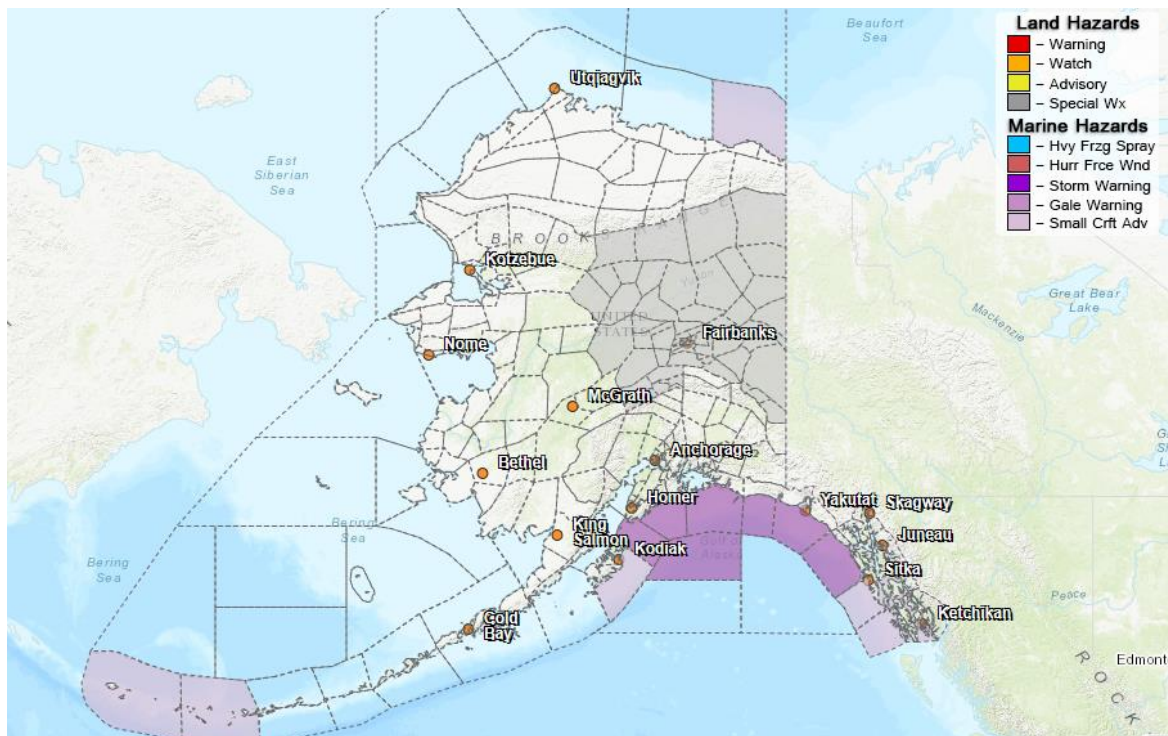

Significant Weather:

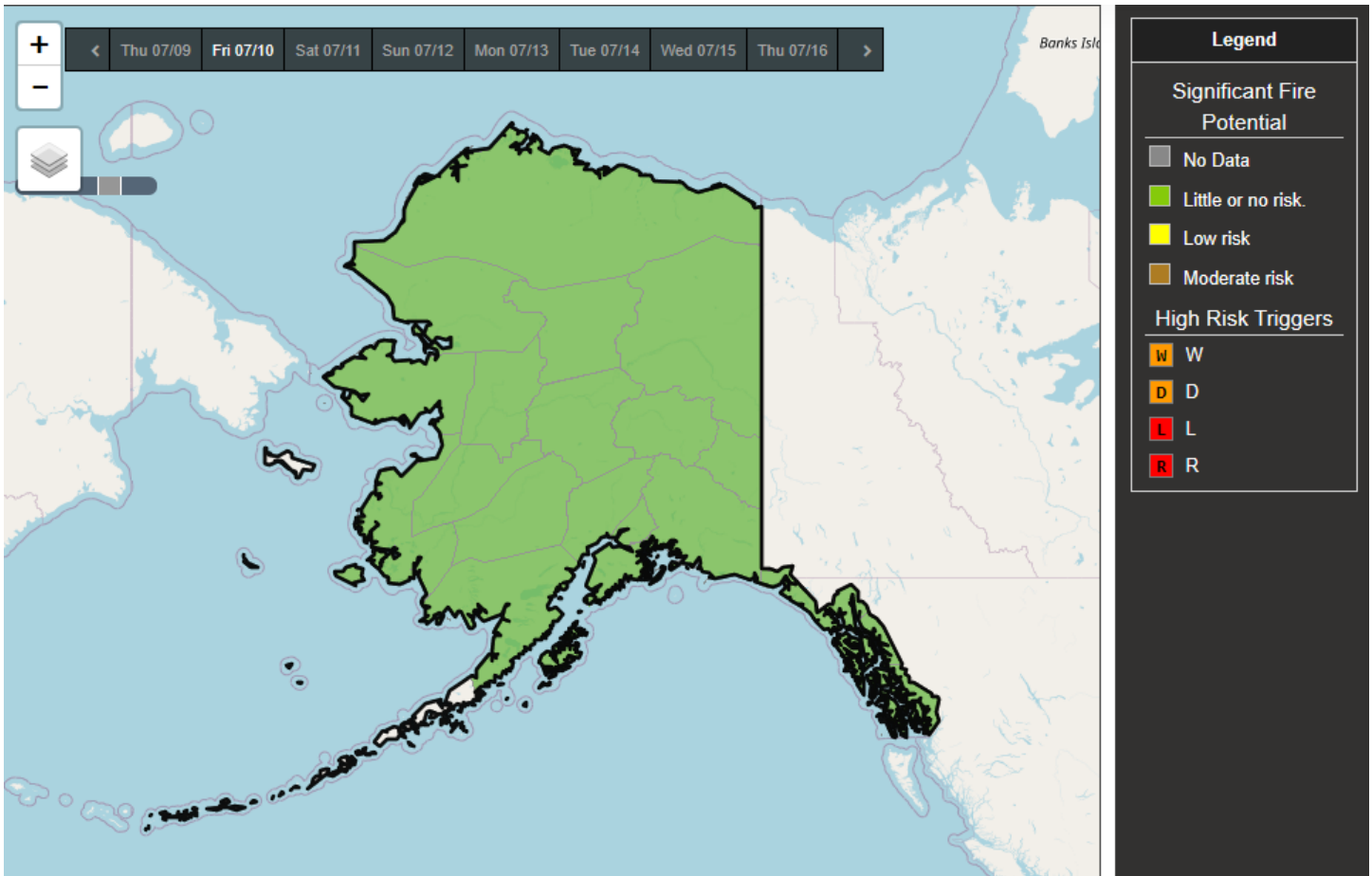


Special weather statement for significant rain over the Eastern Interior in effect until this evening. Most of the Eastern Interior, including Fairbanks can expect between one quarter and one half inch of rain by Tuesday.

Flood advisory for Kennicott River in the Copper River Basin in effect until 10:15am Tuesday. Hidden Lake which is dammed by the Kennicott Glacier has begun to release and is expected to cause the river to rise 3-5 feet over the next 12-24hrs.
