#### **Significant Issues**

At 12:54 P.M. yesterday, a magnitude 7.5 earthquake occurred 55 miles southeast of Sand Point. The National Tsunami Warning Center issued a tsunami warning for the south Alaska coast and Alaska Peninsula from the Kennedy Entrance 40 miles southwest of Homer to Unimak Pass 80 miles northeast of Unalaska. The SEOC recalled Operations staff and executed tsunami warning procedures focused on contacting communities in the tsunami warning area. Small tsunami waves were recorded in several communities along Alaska's coast, including a 2.3 foot wave in Sand Point and a 0.7 foot wave in Crescent City, California. The warning was subsequently reduced to an Advisory at 3:58 P.M. and then canceled at 9:06 P.M.

The SEOC has received preliminary reports of some minor earthquake damage in the Sand Point area. The SEOC has not received any reports of injuries from this incident. The SEOC is actively engaged in contacting communities in the tsunami and earthquake areas to develop additional information on any damages.

# Coronavirus (COVID-19) Pandemic

A unified command has been established at the SEOC. The SEOC continues to support statewide response to COVID-19.


