
Air Quality Index (AQI) Advisories

Significant Weather:



A Winter Weather Advisory is in effect for Bristol Bay and the Kuskokwim Delta until 6:00 P.M. today. Winds gusting as high as 30 mph will create areas of blowing snow. Total snow accumulations of 4 to 8 inches are expected.

A Wind Chill Advisory is in effect for the Taiya Inlet and Klondike Highway until midnight tonight. Wind chills as low as 35 below zero with northeast winds of 15 to 25 mph with gusts to 45 mph are expected.
