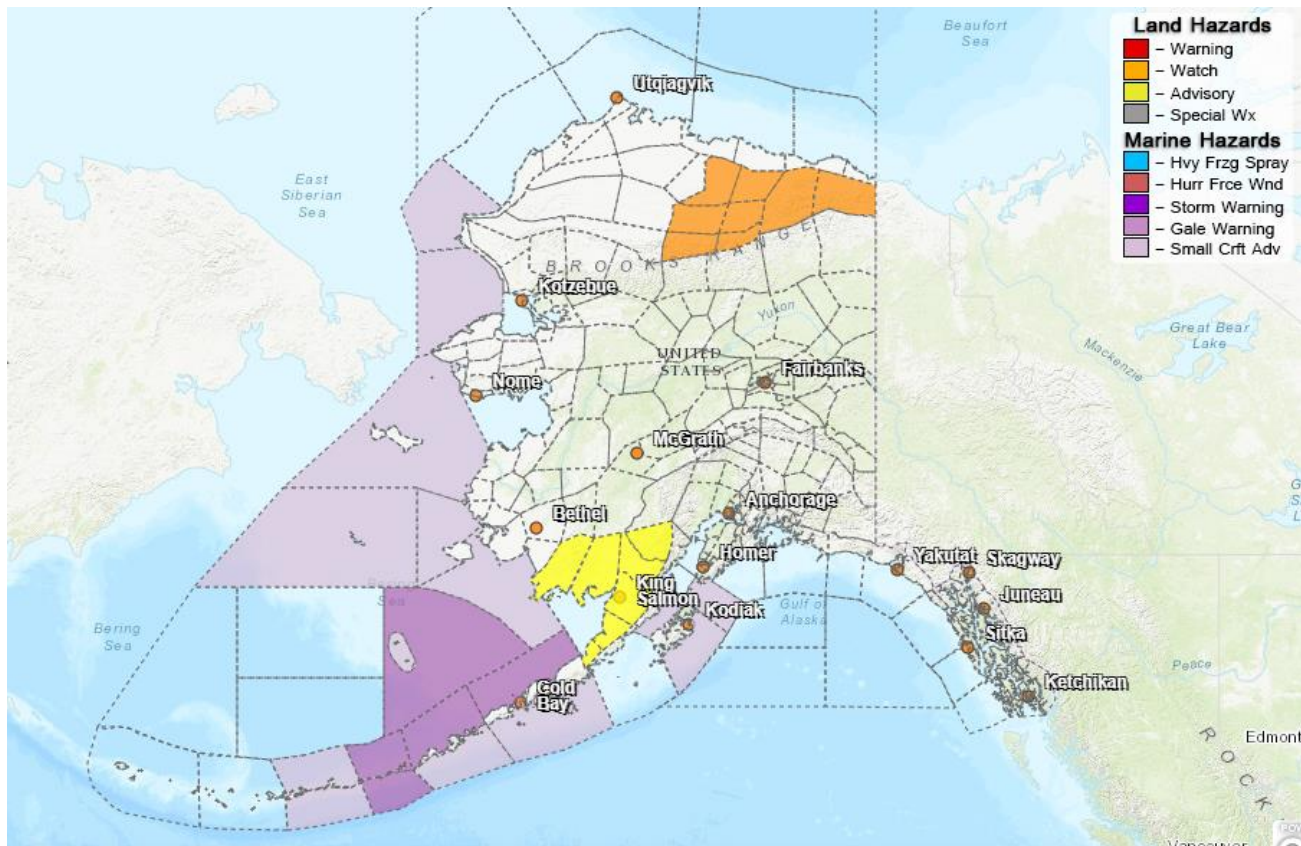

Significant Weather:

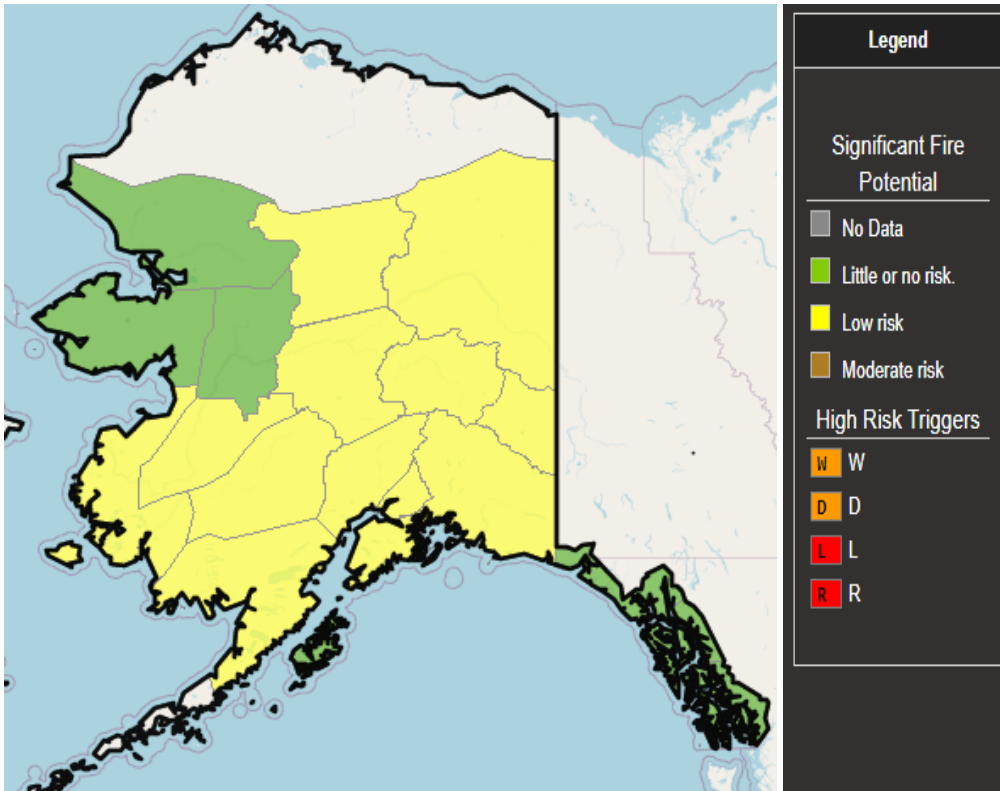


A Smoke Advisory is in effect for Pilot Point and the Bristol Bay area until 10:00 A.M. today. Low visibility is possible due to dense smoke from a wildfire burning near Pilot Point.

A Flood Warning is in effect until Thursday afternoon for the Northeastern Brooks Range due to an ice jam on the Sagavaniroktok River.

Fire Weather:



A wildfire is burning near Pilot Point. The Alaska Division of Forestry (DOF) and the Alaska Bureau of Land Management (BLM) are actively involved in fighting the fire with both ground and air resources.

Burn Permits have been suspended by the DOF for both the Kenai Peninsula Borough and the Mat-Su Borough due to increasing fire danger. Debris/brush burning and the use of burn barrels is prohibited during a burn suspension.
