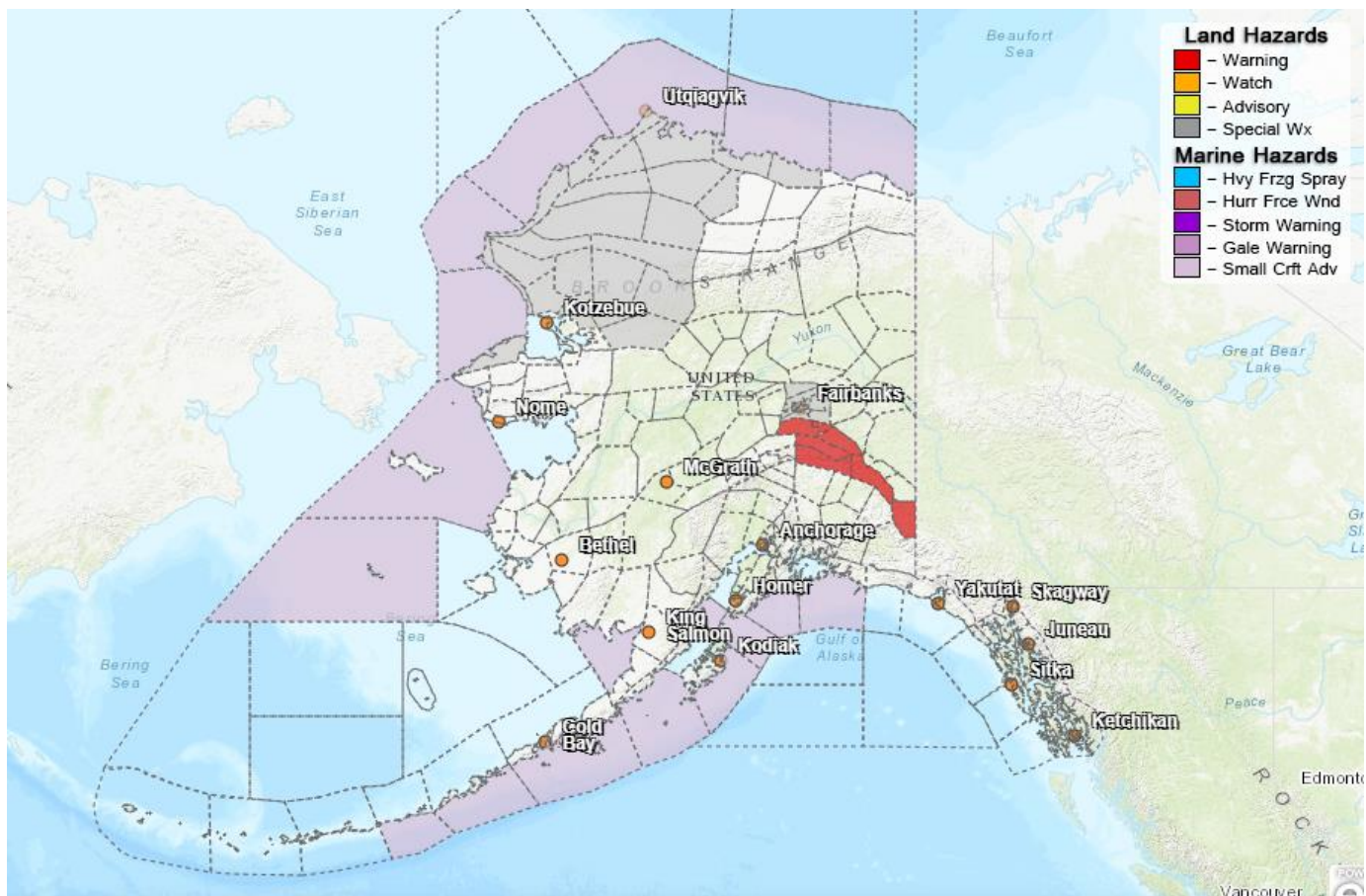

Significant Weather:



A Red Flag Warning is in effect until 10:00 P.M. today for Deltana and Tanana Flats and the Eastern Alaska Range.

A Special Weather Statement has been issued for the Fairbanks and the Middle Tanana Valley due to smoke in the area from wildfires burning in the region.

A Special Weather Statement has been issued for the Chukchi Sea Coast, Central Beaufort Sea Coast, Northern and Western Arctic Coast, Northwestern Brooks Range and the Kobuk and Noatak Valleys. High water levels are expected in larger rivers within these areas over the weekend. No flooding is expected and water levels should begin to drop next week.
