July 2021 Alaska Peninsula M8.2 Earthquake:

The SEOC continues to be in contact with communities in the Alaska Peninsula that were affected by the M8.2 earthquake. The damage assessment is ongoing, but to date, there have been no reports of significant injuries or damages to property or infrastructure from the event.

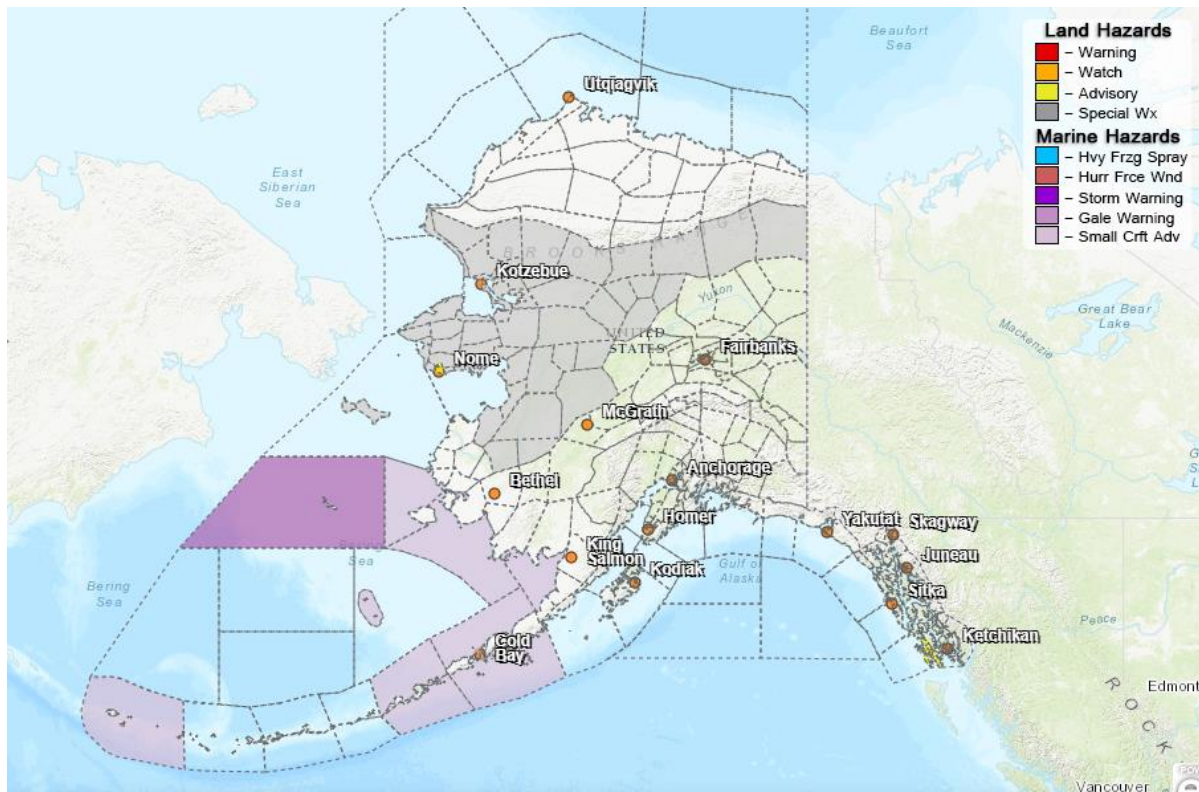

A Flood Advisory remains in effect for the Snake and Nome Rivers until noon on Sunday. An additional 1 to 2 inches of rainfall are possible over the weekend.

A Special Weather Statement remains in effect for the west coast, western and northern interior, and the Koyukuk Valley for another round of significant rainfall that is expected Friday afternoon through Saturday morning. Minor flooding is possible along waterways in the region.
