

Significant Issues:

The Richardson Highway remains closed from MP 218 to MP 234 due to wash out flooding. DOT anticipates this closure will continue through the weekend, depending on weather. The SEOC is assisting DOT&PF with request for federal assistance from Federal Highways Administration Emergency Relief program.

Statewide Fires

Evacuation level changes have been made on the Clear Fire #346. The city of Anderson, Clear, Clear Space Force Station, Bear Creek and June Creek have been reduced to "Ready" status. All areas accessed by Kobe Road and all cabins along the Teklanika River within two miles of the current fire perimeter ARE STILL IN "GO" STATUS.

SEOC remains at Preparedness Level 2 - *Heightened Awareness* in response to the statewide fire situation. SEOC is monitoring multiple fires that pose some risk to communities and is participating regularly in Incident Management Team Cooperator briefings for these fires.

SEOC has a Disaster Division Supervisor and the Mobile Emergency Operations Center at the Minto Lakes Fire (#349) to support fire operations. Several areas of the FNSB in the Chatanika River Corridor remain evacuated with a shelter location at the Randy Smith Middle School and pet shelter at the Fairgrounds ready if needed.

SEOC is in regular contact with both Denali and Fairbanks North Star Borough's Emergency Management coordinating state support on multiple fires. SEOC has multiple staff engaged in fire response support operations and is in daily contact with State Forestry for contingency planning of mass care, evacuation, National Guard, and other resources.

Threat Level Changes:

None.



Significant Weather:



Special Weather Statements have been issued for the following areas:

- Copper River Basin The Kennicott Glacier Dammed Hidden Lake is releasing and may cause a significant rise on the Kennicott River near McCarthy. Water levels may rise an additional 2 to 5 feet over the next 24 to 48 hours.
- Central Interior and the Tanana Valley High water is expected to continue on the Tanana River through the weekend.
- Denali and the Eastern Alaska Range Heavy rain is expected across the area over the weekend.
