

# Significant Weather:



High Wind Warnings are in effect for the following areas:

- Western Arctic Coast until 9:00 P.M. tomorrow. 40 mph winds with gusts to 65 mph.
- St. Lawrence Island, the Bering Strait Coast and the Chukchi Sea Coast until 6:00 P.M. tomorrow. 50 mph winds with gusts to 70 mph.

High Surf Advisories are in effect for the following areas:

• St. Lawrence Island and the Bering Strait Coast until 6:00 P.M. tomorrow. Beach erosion and minor flooding of low lying areas is possible.

- Chukchi Sea Coast until midnight tomorrow. Beach erosion is possible from Kivalina north along the coastline.
- Northern and Western Arctic Coast. Elevated water is expected through 6:00 A.M. Thursday.
