Overview: One low pressure system is moving into the Chukchi Sea while a separate low and its associated front is moving into the Gulf of Alaska, conditions will improve briefly Thursday as a ridge will move from the Bering Sea towards Anchorage. A potent low will then move along the Aleutians and bring gusty winds, rain and snow Friday into Saturday

Hooper Bay: Wednesday conditions improve but lingering clouds likely in the passes, dry conditions with light winds Thursday, could still be lingering clouds in passes, temperatures in the 30s with lows in the 20s

Anchorage: Lingering snow showers Wednesday and likely low ceilings and visibilities in nearby passes, partly cloudy by Thursday afternoon with highs in the 30s
