

# Winter Storm Warnings:

Copper River Basin (Richardson Highway) – Warning remains in effect through 9:00AM Thursday.
 Heavy snow expected. Total snow accumulations of 10 to 16 inches. Plan on hazardous travel conditions.

#### **Blizzard Warning:**

Northeast Prince William Sound (Thompson Pass) – Warning remains in effect through 9:00PM this evening. Blizzard conditions expected. Total snow accumulations of up to 28 inches through Wednesday evening. Northeast winds gusting 30 to 45 mph.

# **High Wind Warnings, High Wind Watches, & Advisories:**

- Prince of Wales Island Warning remains in effect from 6:00PM this evening through 9:00AM Thursday. Southeast winds 30 to 40 mph with gusts up to 65 mph expected.
- City and Borough of Yakutat Warning in effect from 3:00PM this afternoon through 3:00 AM Thursday. East winds 35 to 45 mph with gusts up to 65 mph expected.
- **Southeast Prince William Sound** Warning in effect from 1:00PM today through 11:00AM Thursday in Cordova area. East winds 35 to 55 mph with gusts up to 85 mph expected.
- Northwest Arctic Coast; Northern Arctic Coast; Central Beaufort Sea Coast; Eastern Beaufort
  Sea Coast Watch is now in effect from late tonight through Friday morning. Northeast winds 35 to
  45 mph with gusts up to 65 mph possible.
- Prince of Wales Island; Ketchikan Gateway Borough; Annette Island Watch is in effect from this afternoon through Thursday morning. Southeast winds 20 to 30 mph with gusts up to 60 mph possible.
- **Eastern Alaska Range North of Trims Camp** Advisory in effect from 5:00 AM to 9:00 PM Thursday. Southeast winds 35 to 45 mph with gusts up to 65 mph expected.
- Northern Denali Borough; Southern Denali Borough Advisory in effect through 9:00 PM
  Thursday. Southeast winds 30 to 40 mph with gusts up to 60 mph expected from north of Cantwell to
  Denali.
- **Delta Junction** Advisory remains in effect until 9:00 PM this evening. East winds 30 to 40 mph with gusts up to 55 mph expected.

#### Winter Weather Advisories:

- Anchorage Advisory in effect through noon Thursday. A wintery mix of precipitation today. Heavy
  Rain on snow and ice tonight and Thursday morning. The main hazard is expected to be when snow
  transitions to rain this evening.
- Western Prince William Sound (Turnagain Pass to Summit Lake) Advisory in effect until
   5:00PM Wednesday. Snow expected, with total snow accumulation 6 to 12 inches.

#### Flood Watches:

- East Turnagain Arm (cities of Girdwood and Portage) Watch in effect from Wednesday morning through Thursday evening. Heavy rain may fall on the existing snowpack leading to increased runoff. Flows in rivers may increase quickly and reach impactful levels.
- Anchorage Watch in effect from Wednesday through Thursday Afternoon. Flooding caused by rain and snowmelt continues to be possible in the Anchorage Bowl including the cities of Anchorage, Eagle River, Indian, And Eklutna.
