Significant Issues:

Juneau Suicide Basin Flooding

The SEOC met with the City and Borough of Juneau and is continuing to support them with response and mass care needs from this weekend's flooding. They have issued local disaster declaration asking for state assistance for flood impacts. The SEOC is reviewing their declaration and will support them through the assistance process.

Statewide Wildland Fire Situation and State SEOC Fire Support:

Delayed onset of season-ending rains has resulted in deeper drying of duff layers and greater fuel availability than typically seen this time of year. There are numerous fires near core population areas and new starts continue to be discovered in these areas and are resistant to containment. Multiple days of wetting rain adding up to more than one inch will be needed for lasting relief. Red Flag Warnings have been canceled, leaving a large portion of the interion under dense smoke advisories. AKNG, SEOC, and other partners are continuing to support, and SEOC will continue to monition conditions. Red Cross, Salvation Army, and other VOAD partners are still on standby ready to support if necessary.

Fairbanks Area Fires:

Due to continued fire suppression success, the Fairbanks North Star Borough was able to make changes in their evacuation levels. The Upper Haystack Subdivision changed from level 3 (GO!) back to level 2 (SET), effective at 8:00 PM last night. The McCoy Creek Fire #201 is still ongoing. A Level 3 (GO!) evacuation status still remains in effect for residents in the Lower Salcha River, approximately from river mile 3 to 40. SEOC was in regular contact with Fairbanks North Star Borough and forestry throughout the weekend and will support with statewide resources as required.

Anderson Complex:

SEOC has a Division Supervisor in Anderson / Healy to support the Borough Emergency Management and the Mobile Emergency Operations Center is still being utilized as an Incident Management Command Post. Rain and cooler temperatures have helped fire crews combat fires in the area. Evacuation levels remain in place.

Delta Junction Area

Fire suppression efforts continue in the Delta area on multiple fires. Tanana Chiefs crew worked with forestry to protect structures, while aircraft and jumpers continued working on other fires. Fire Management Officer Michael Goyette cautioned residents and visitors to take precautions regarding health, visibility and driving impacts due to heavy smoke conditions.

Air Quality Index (AQI) Advisories

Air Quality Advisory still in effect for Central and Eastern Alaska and for South Central Alaska; and Southeast Alaska until 2 PM AKDT on Tuesday August 8, 2023. Severe smoke impacts within the Tanana Flats/Valley. With wind air quality will vary between GOOD and HAZARDOUS.

Air Quality Advisory issued for the North Slope as smoke from Canadian fires have migrated into the eastern portion of the North Slope combined with Upper-level smoke settling to the surface from the Interior fires. Advisory is valid until Tuesday August 8, 2023, at 2:00PM.



Red Flag Warnings:

 Yukon Flats and Surrounding Uplands - Warning in effect from 4:00PM this afternoon through midnight tonight Frequent lightning could cause new fire starts. Thunderstorms will cause gusty and erratic winds in the late afternoon and evening.

Dense Smoke Advisory

• Central Interior, Deltana and Tanana Flats, Middle Tanana Valley, Upper Koyukuk Valley and Upper Tanana Valley and Fortymile Country – In effect until noon today causing hazardous driving conditions due to low visibility. Dense smoke is hazardous to health.
