Significant Issues:

Juneau Suicide Basin Flooding:

SEOC deployed a Branch Director who was accompanied by a Volunteer Agency Specialist for the Salvation Army. They are currently in Juneau offering scene assistance and coordination of mass care, volunteer offers of assistance, and donation management.

SEOC Individual Assistance (IA) Group opened the State Disaster IA applications by phone and web site today and plans to open a Disaster Assistance Center in Juneau the week of August 21. Web Site for IA Registration for the Juneau disaster is: https://ready.alaska.gov/Recovery/IA

The Red Cross is continuing residential damage assessments in the flood area and is opening an assistance center in Juneau for disaster survivors.

Statewide Wildland Fire Situation:

With a change in weather, wildland fire activity is decreasing, with most of the fire concern in areas of the state that have not yet received significant precipitation. However, there are still 14 staffed fires in the state with over 980 fire fighters actively engaged in suppression and over 270,000 acres burned this year.

SEOC has the Mobile Emergency Operations Center deployed to the Anderson Fire Complex with an SEOC Operations Specialist. Alaska National Guard Armory in Fairbanks continues to support fire crew mobilization.



Significant Weather:



The following Warnings, Watches, and/or Advisories have been issued:

- <u>Dense Smoke Advisory</u> in effect for the Middle Tanana Valley, Central Interior, Yukon Flats and Surrounding Uplands until 12 PM AKDT this afternoon.
- Special Weather Statement issued for this weekend for the City and Borough of Yakutat; Eastern Chichagof Island; Cape Fairweather to Lisianski Strait; City and Borough of Sitka; Admiralty Island; Petersburg Borough; Western Kupreanof and Kuiu Island; Prince of Wales Island; City and Borough of Wrangell; Ketchikan Gateway Borough; City of Hyder; Annette Island. A gale force low with a significant source of tropical moisture will enter the Gulf of Alaska Saturday through Sunday morning.
- Special Weather Statement issued for the City and Borough of Juneau for this weekend. A gale force low
 with a significant source of subtropical moisture will enter the Gulf of Alaska Saturday. This system will bring
 moderate to heavy rain and windy conditions to the Panhandle Saturday and Sunday.
 For those along the Mendenhall River, the rainy and windy conditions could increase the risk of trees falling
 into and around the river from the already unstable riverbanks.
