# Wrangell Landside Disaster:

#### **Manokotak Power Outage:**

SEOC has been notified that the school generator has been repaired so the school can be used as emergency shelter if needed. The community generator is running and being maintained by a local operator until AEA gathers the needed parts. The community is no longer doing rolling blackouts. SEOC continues to actively monitor progress with community officials and mass care partners.

#### **Point Hope Power Outage:**

SEOC is actively monitoring Point Hope's response with community officials and the North Slope Borough.

#### Selawik Power Outage:

SEOC, Northwest Arctic Borough and AKVOAD continue to work with the City of Selawik to support any unmet needs due to a power outage and freeze up.





# Winter Weather Advisory:

- Municipality of Skagway; Haines Borough and Klukwan from noon today until Thursday at noon for snow between 4 to 8 inches and winds gusting to 30mph.
- Yukon Delta Coast until Thursday at 6am for snow of up to one inch and winds gusting to 40mph.
- St. Lawrence Island until Thursday at 2pm for snow up to one inch and winds gusting to 40mph.
- Southern Seward Peninsula Coast from noon today until Thursday at 3pm for blowing snow and winds gusting to 45mph.
- Bering Strait Coast until Thursday at 6pm for blowing snow and winds gusting to 40mph.
- Northeast Prince William Sound from 9am this morning until Thursday at 1am for blowing snow and snow up to 10 inches; winds gusting to 40mph.
- Central Brooks Range until Friday at 3pm for blowing snow and winds gusting to 50mph.
- White Mountains and High Terrain South of the Yukon River until Thursday at 9am for blowing snow and winds gusting to 40mph.
