<u>Significant Issues:</u>

Juneau Weather

SEOC has been in contact with the community throughout the weekend. 9 total vessels have sunk, minor flooding reported in some areas, but no current concerns from the city/borough or coast guard. The SEOC will continue to monitor the community during the weather event.

North Slope Borough Fire

The North Slope Borough Emergency Manager contacted the SEOC this past Friday to report a structure fire at the "Shipping & Receiving Building/EOC" in Utqiagvik. It is reported to be a total loss. The building is currently still smoldering, and the community is waiting for arrival of the Fire Marshall to investigate. No injuries were reported. There have been no requests made for assistance. The SEOC will continue the monitor the event.


