Significant Issues:

Chalkyitsik - Power Outage

SEOC was in contact with the DOT&PF Liaison who has identified contingency plans for emergency airport lighting if power is not restored to support medevac and additional travel. SEOC also spoke with AEA who confirmed they have had a technician in the community since Saturday working to restore power. Additional needed parts were identified, and the technician plans to return depending on weather conditions to continue repairs.

Koyukuk – Freeze Up

SEOC was actively engaged with multiple partner agencies including the city, Koyukuk Native Village, Salvation Army, TCC, and the VOADs. TCC Remote Maintenance Workers (RMW) continue to work on repairs to the water pump and water plant, work has been hindered due to extreme cold temperatures and the need for additional parts. The community is continuing to use a combination of private wells and drilling holes in the river ice to haul water for basic sanitation in the community.

Mertarvik – Power Outage

SEOC confirmed with Fox Air that 1,080 pounds of bottled water and 1,600 pounds of firewood has been delivered to the community with additional flights of bottled water and firewood still planned. The bottled water and firewood have been sourced by BIA and transportation of the supplies has all been donated by Fox Air. SEOC received reports form the community that the supplies are already getting distributed out within the community.

Quinhagak Power Outage Disaster




Avalanche Hazards:
