Significant Issues:

Chignik Bay - Avalanche and Power Outage

SEOC was contacted on Friday night regarding an avalanche which resulted in a community wide power outage in Chignik Bay. No injuries or missing persons, nor any immediate mass care needs were reported. Alaska Energy Authority (AEA) arranged for a lineman from Dillingham to fly to the community and work with local power plant operators to begin repairs. The lineman was delayed due to weather but was able to fly yesterday.

SEOC remains in close contact with community leaders, DOT&PF, and AEA in support of response and recovery.

Kotzebue – Frozen Water Lines

The city hosted a teleconference on Friday with members from the SEOC, Native Village of Kotzebue, Northwest Arctic Borough, DEC, Representative Baker's office, FEMA, the School District and NANA. SEOC also coordinated with the Red Cross to send portable potable 5-gallon buckets/cubees, which were sent and distributed to the priority homes throughout the community.

SEOC will deploy a staff member to the community this afternoon to help with the continued coordination of the response and recovery.




Avalanche Hazards:
