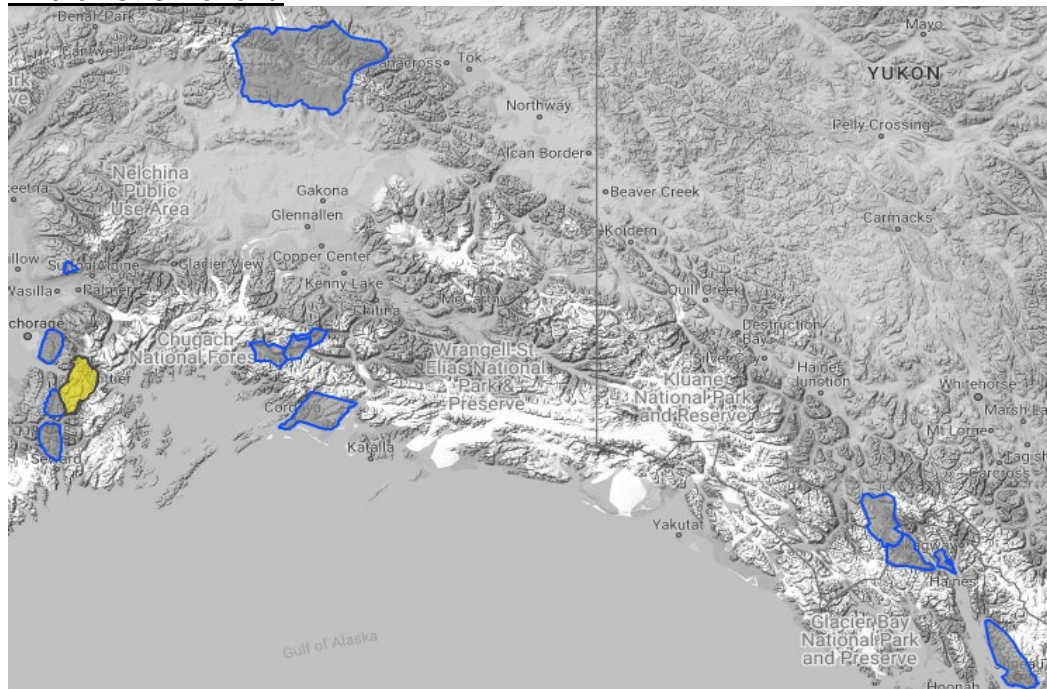

Avalanche Hazard

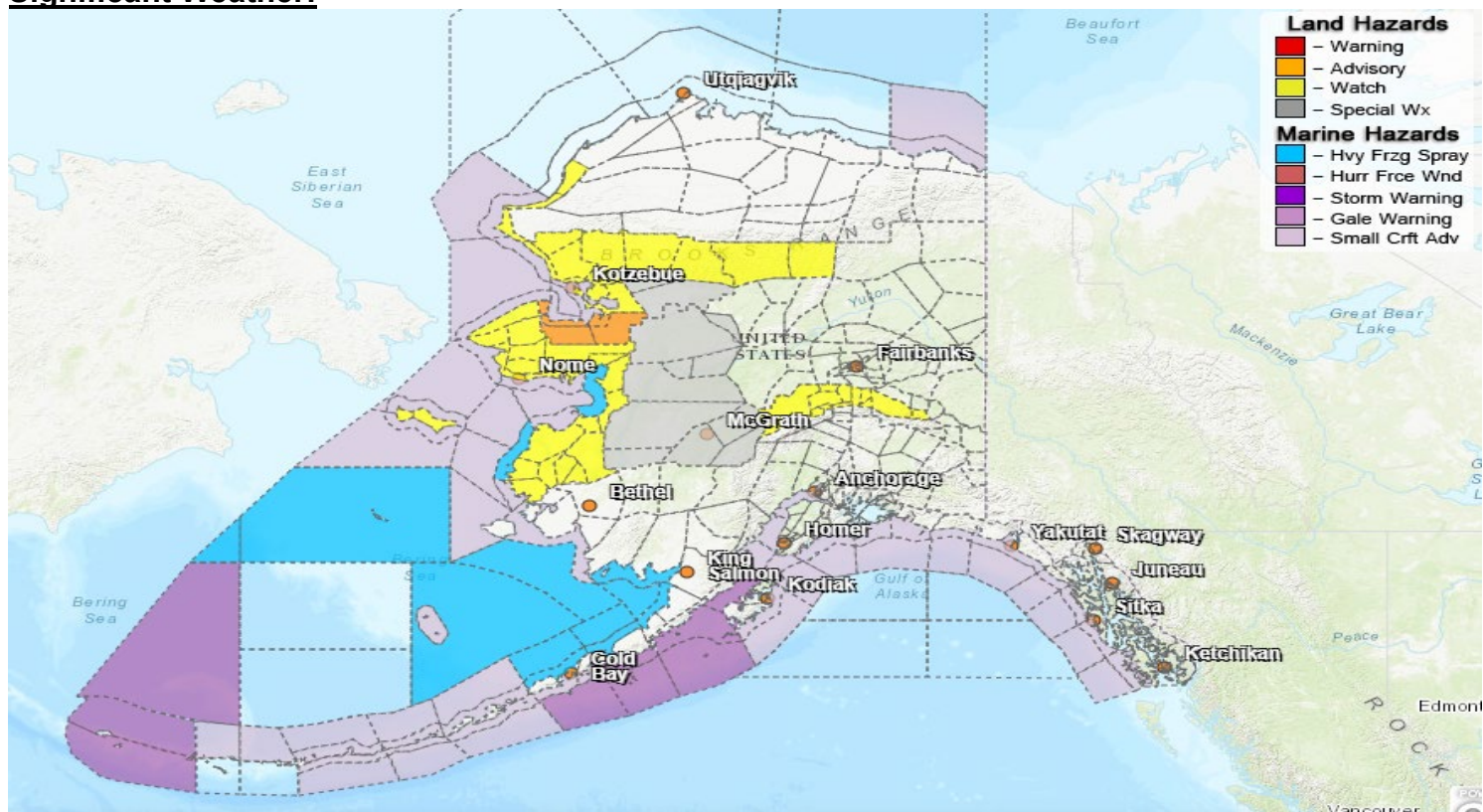


Travel in avalanche terrain is not recommended. Avoid being on or beneath all steep slopes.
