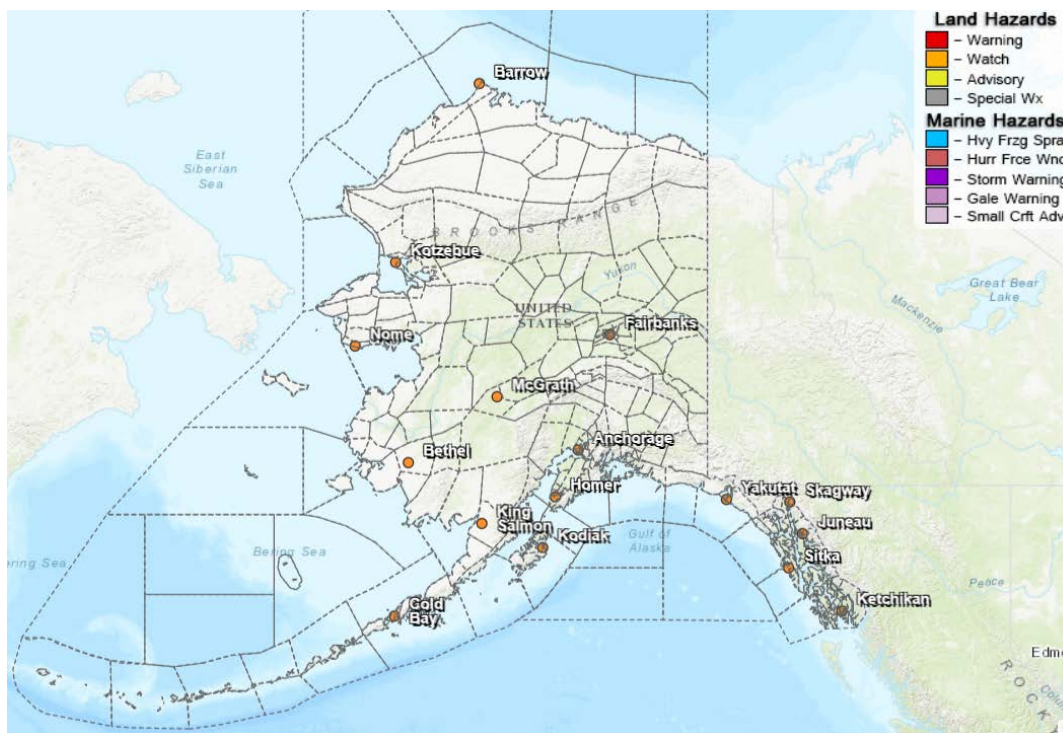

Selawik experienced a widespread freezing event that has effected the city's water and sewer service to approximately 25% of the community. The SEOC is in communication with the City of Selawik, Northwest Arctic Borough, and Alaska Native Health Consortium to assess the current situation.
