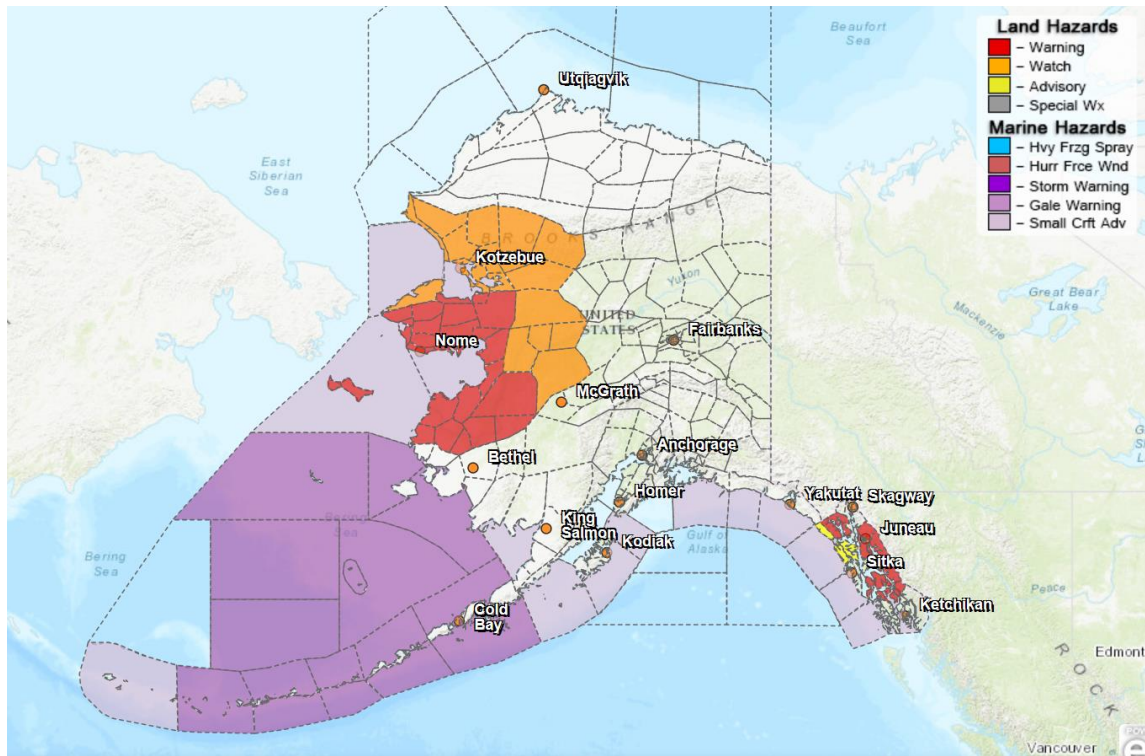
**Cook Inlet Earthquake**

The President has declared this event a federal disaster (FEMA 4413 DR) approving Individual Assistance, Public Assistance, and Statewide Hazard Mitigation for the M7.0 earthquake affecting the Municipality of Anchorage, Matanuska-Susitna Borough, and Kenai Peninsula Borough. The SEOC remains activated to Level 3. Approximately 150 FEMA and SBA staff have arrived in Alaska to support the federal declaration. FEMA command and general staff will operate out of the SEOC until a Joint Field Office (JFO) can be set up.
