**Cook Inlet Earthquake (FEMA Declaration 4413-DR)**

The SEOC remains activated to Level 3. FEMA command and general staff will operate out of the SEOC until a Joint Field Office (JFO) can be set up. FEMA continues to operate a personnel mobilization center (PMC) in Anchorage to provide orientation, equipment, and other logistical support for incoming federal staff supporting the federal declaration. The Small Business Administration continues to operate a business recovery center in Eagle River and has made 150+ telephone contacts. FEMA disaster survivor assistance (DSA) teams continue to work with local government officials in all three affected jurisdictions.

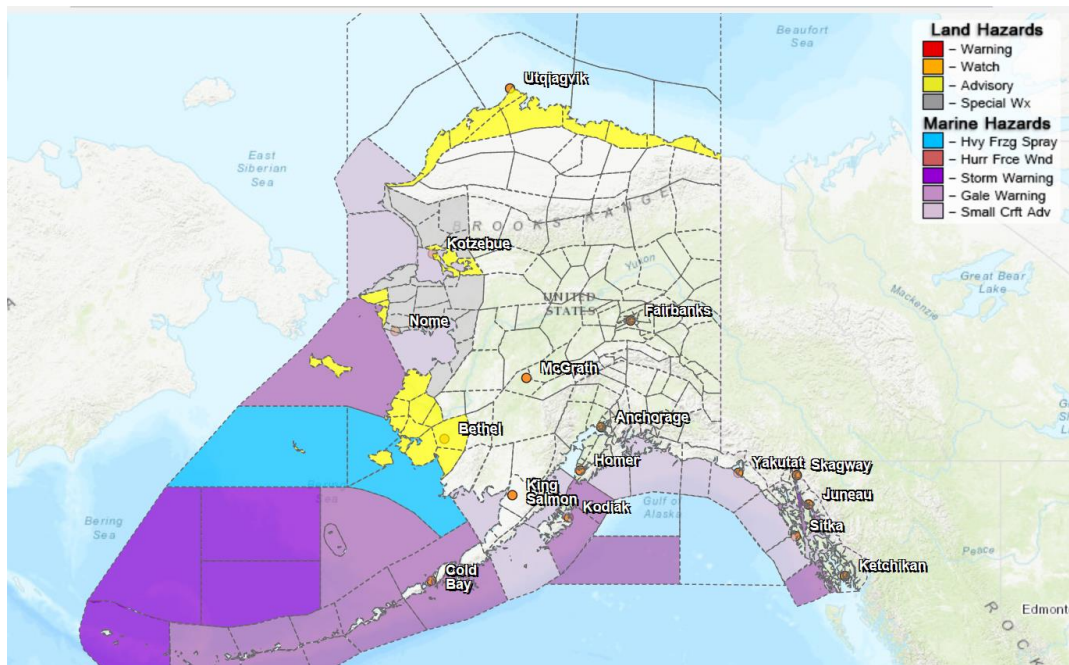
**Kotlik Storm Impacts**

The SEOC received a call this morning from the tribal administrator for the Kotlik Traditional Council who reports the recent storms and high winds over the past two days had pushed floodwater into the community affecting at least three houses. She will consult with other local community officials today and provide the SEOC with a complete assessment of the storm’s impacts today.
