Cook Inlet M7.1 Earthquake (FEMA Declaration 4413-DR)

This is the **125th** day since the earthquake. FEMA has opened their Joint Field Office, (JFO) for this disaster at the Alaska Area Office in Anchorage. FEMA has **240** persons and four Disaster Recovery Centers working in Alaska. To date, FEMA has dispensed over **\$8.1** million in Individual and Households Program funds and almost **\$7.9** million in Housing Assistance funds. SBA has approved **842** home loans and **43** business loans totaling over **\$40.4** million.

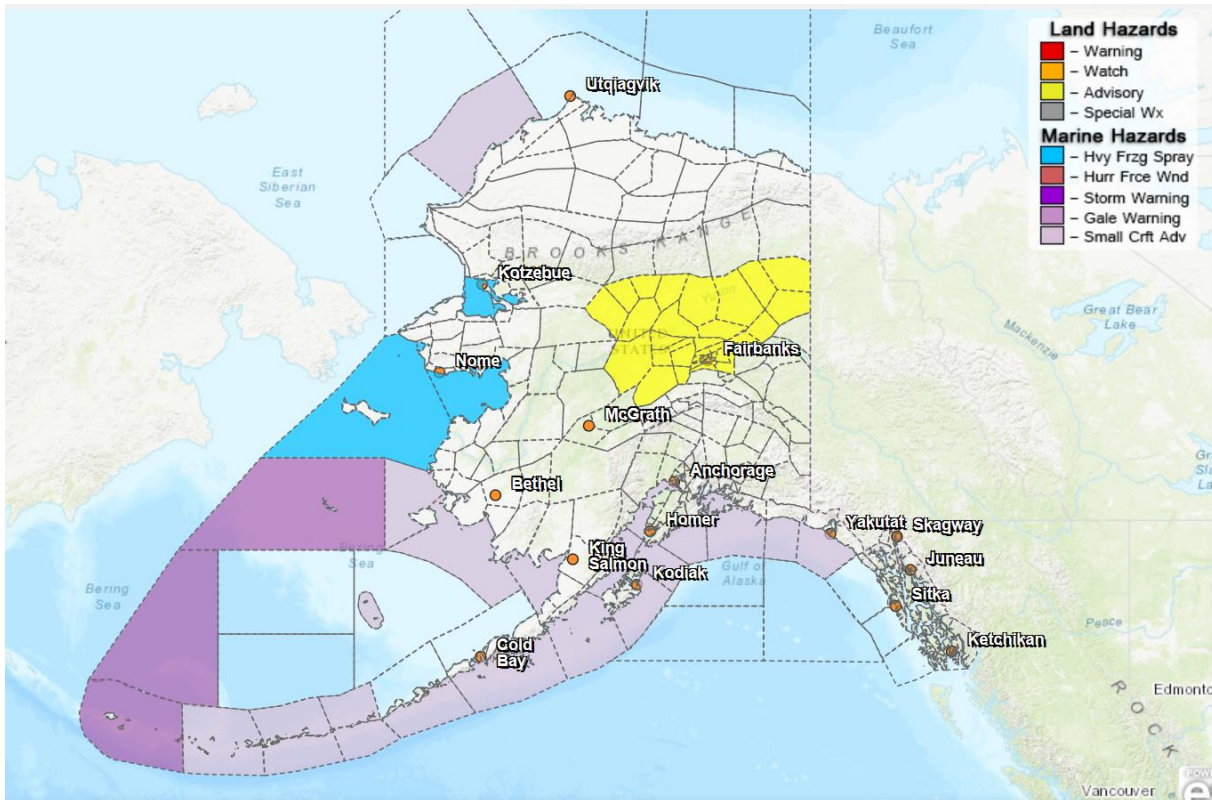
Diomedes Power Issues
