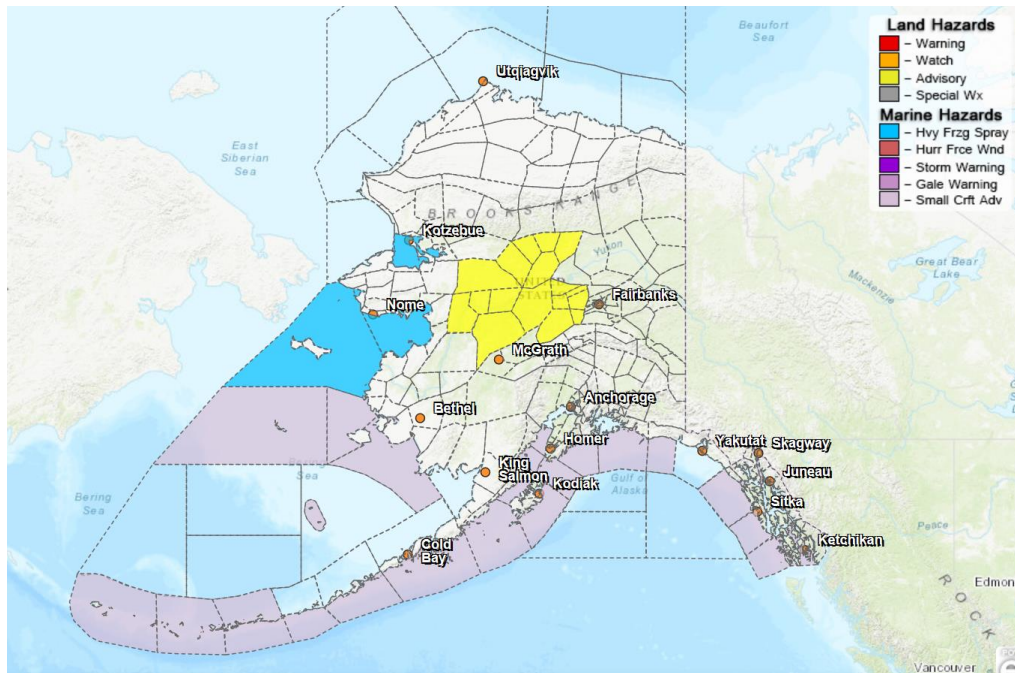
**Cook Inlet M7.1 Earthquake (FEMA Declaration 4413-DR)**

This is the **126th** day since the earthquake. FEMA has opened their Joint Field Office, (JFO) for this disaster at the Alaska Area Office in Anchorage. FEMA has 240 persons and four Disaster Recovery Centers working in Alaska. To date, FEMA has dispensed over \$8.1 million in Individual and Households Program funds and almost **\$8.0** million in Housing Assistance funds. SBA has approved 842 home loans and **44** business loans totaling over **\$40.5** million.
